MAY 16, 1960

A Regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, May 16, 1960 at 7:30 p.m.

PRESENT: Reeve Emmott in the Chair; Councillors Drummond, Edwards, Harper, Jamieson, Mather and Prittie.

Canon T. dePencier led in Opening Prayer.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR EDWARDS:

"That the Minutes of the meetings held April 19th, 21st, 25th, May 2nd and 9th, 1960 be adopted as written and confirmed."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR MATHER, SECONDED BY COUNCILLOR EDWARDS:

"That Councillor MacSorley be granted leave of absence from this meeting."

CARRIED UNANIMOUSLY

The Reeve announced that a number of members of the Toastmistress Club were present at the meeting this evening. He introduced them and welcomed them to the meeting.

His Worship, Reeve Emmott then presented a Parchment Certificate, awarded by the Royal Canadian Humane Association, to Mr. James Strangeway, 7085 Gray Avenue, for his heroism in saving the life of a $3\frac{1}{2}$ year old child who had fallen into the South Thompson River on January 27, 1959 at Kamloops, B. C.

Parks and Recreation Commission forwarded a letter which it had received from Auto Courts and Resorts Association of B. C. in which a request was made for a financial contribution of \$250.00 to assist in the preparation of a brochure publicizing the various tourist attractions of the Lower Mainland area. The Chairman of the Publicity Committee reported that her Committee had considered this request and though the Committee was in support of the proposal to develop a brochure of the kind described, it was unable to recommend that the application be approved since grants have already been made to local organizations for purposes similar to those proposed by the Associatio. The Chairman pointed out that because of this situation, funds were not available to provide additional grants. The Chairman of the Committee recommended that because of the foregoing reasons, the request be denied.

Transportation Committee submitted a report advising that it had considered the report of the Special Committee on Transit dated October 26, 1959 relative to transit services in the Municipality and that it was of the opinion the revisions therein recommended are a decided improvement in that service will be extended closer to the newly developed areas and to shopping centres. The Committee pointed out that implementation of the new route proposal is dependent to some degree on road conditions. The Committee recommended that before any formal approaches are made to the B. C. Electric Company, up-to-date information on the condition of the affected roads be obtained from the Municipal Engineer. The Committee added that upon receipt of this information, it would be in a position to make concrete recommendations to Council for implementation of at least part of the overall plan.

(8) Employee Life Insurance Policy.

The Manager reported that the above policy (G-3524) of the London Life Insurance Company provides death and disability benefits to the employees of the Corporation. He advised that it has a premium rate structure based on 1957 discounted rates and that the Company wished to change this structure to the 1959 basis effective July 1, 1960. The Manager recommended that Council authorize the execution of the authorization of the London Life Insurance Company to amend the terms of Group

Policy G-3524 so that effective July 1, 1960, the provisions of the Company's current rate basis (known as the 1959 rate basis) will be substituted for the corresponding provisions at present contained in the said policy.

MOVED BY COUNCILLOR JAMIESON, SECONDED BY COUNCILLOR EDWARDS:

(9) Hawthorne Avenue, south of Kingsway.

The Manager advised that the Municipality owns Lots 7 and 10 to 13 inclusive, D.L. 96 and that the School Board has acquired property east of the aforementioned Lot 13 and desired to consolidate all of the parcels in question with the site of the South Burnaby High School. He advised that to effect this consolidation, it would be necessary for the Corporation to abandon Hawthorne Avenue Letween Kingsway and Beresford Street. The Manager recommended that Council authorize the abandonment of the portion of Hawthorne Avenue mentioned.

MOVED BY COUNCILLOR JAMIESON, SECONDED BY COUNCILLOR MATHER:

"That the recommendation of the Manager be adopted."

(10) Club Regulation By-law.

The Manager reported that a petition has been received from the Vancouver Heights Social Club requesting that the above By-law be amended to allow the Club (and others of the same kind) to remain open all night. The Manager advised that the Chief Licence Inspector had recommended that the By-law be amended to provide that private clubs may close at 2:00 o'clock a.m. rather than midnight but that he did not concur with this recommendation and instead was recommending that there be no change in the existing regulations requiring closing at 12:00 o'clock midnight.

> MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR JAMIESON:

"That this item be tabled for a period of onc week pending the return of the Municipal Manager."

> CARRIED COUNCILLOR PRITTIE AGAINST.

(11) Drainage from Brantwood Shopping Centre.

The Manager reported that in order to provide downstream drainage for the above area, it is necessary to construct a 30 inch diameter storm sewer and turn it into an open ditch along the B. C. Electric Burnaby Lake right-of-way west of Willingdon Avenue. He recommended that authority be granted to execute an agreement between the Company and the Corporation to permit the Municipality to instal the above mentioned storm sewer and empty it into the open ditch on the Company property.

MOVED BY COUNCILLOR PRITTIE, SECONDED BY COUNCILLOR EDWARDS: ...

(12) Estimates.

The Manager submitted the Municipal Engineer's report covering Special Estimates of Work in the total amount of \$14,845.00 recommending that they be approved,

A discussion then ensued as to the method which had been employed in connection with the distribution of certain literature promoting the recent Sewer Financing By-law. It was contended that the Publicity Committee had acted in a discriminatory way by circulating the second (orange) pamphlet to only certain sections of the Municipality, particularly when it was this pamphlet which contained a direction to the taxpayers as to the place to vote.
