An Adjourned Meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Friday, December 23, 1960 at 4:15 p.m.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR EDWARDS:

That the Council resolve into Committee of the Whole at 4:15 p.m."

CARRIED UNANIMOUSLY

MUNICIPAL MANAGER -- REPORT NO. 55, 1960.

(1) Re: Insurance.

The Municipal Manager submitted the following information taken from a letter from the Municipal Treasurer concerning the recent call for tenders for Burnaby's insurance:

- (a) The specification used is for the type of insurance coverage the Municipality wishes to have and is designed for this purpose only and not to favour or exclude any section of the insurance market.
- (b) No objection was received from any source as to the specification until a few minutes before tenders closed.
- (c) No request for extension of time for tendering was received.
- (d) At least two tenders have been received which are expected to comply with the tender call.
- (e) The Canadian Underwriters Association has now officially advised the Corporation that the specification for fire insurance is not acceptable to the Companies that are members of that Association and have suggested that, in future, they may have an opportunity to make suggestions in regard to the form of wording before it is incorporated in the specifications.
- (f) Interim insurance on a short-rate basis can be procured but unless this coverage happens to be placed with the successful ultimate tenderer it would cost the Corporation more for this interim coverage than would insurance on a long term basis.
- (g) Tenders now in hand should be dealt with by Council either by opening and considering or by rejection without opening.

Your Municipal Manager holds the opinion that:

(1) For the purposes of obtaining insurance as desired for the Municipality the tender call and specifications should stand:

(2) Before another call for tenders for insurance is made by the Municipality the specifications be reviewed and competent advice obtained on any modifications to the specifications.

The Manager recommended that Council validate the tender call and consider the tenders received.

The Canadian Underwriters' Association wrote advising that the form of wording submitted for fire insurance in this Corporation's tenders for insurance was not acceptable to the Member Companies of their Association. The Association suggested that it was not in the best interests of the public to issue tender forms which may only be acceptable to a limited section of the insurance market. The Association further suggested that in the future their membership may have an opportunity to make submissions in regard to the form of wording before incorporation in the specifications.

MOVED BY COUNCILLOR JAMIESON, SECONDED BY COUNCILLOR PRITTIE:

"That the recommendation of the Municipal Manager be adopted."

CARRIED COUNCILLOR DRUMMOND -AGAINST.

A general discussion followed on the advisability or otherwise of increasing the public liability coverage over the present \$200,000.00 mark, bearing in mind structures under the jurisdiction of the Municipality such as park stadiums where groups of people congregate and where public liability claims may be heavy in the event of structure collapse.

The Municipal Manager was requested informally to inquire into this aspect of the insurance coverage.

The question of acceptability or otherwise of a tender received 35-minutes beyond the legal deadline was considered.

The eight points contained in the Unions submission were read by the Executive Assistant and the Council expressed the desire that these points be presented in written form for further consideration by the Council.
