

OCTOBER 21, 1963

An Adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, October 21st, 1963 at 7:30 p.m.

ABSENT: Councillor Harper

The Canadian Red Cross Society, as represented by Mr. E. L. Coughlin, presented a Certificate saluting the citizens of Burnaby in deep appreciation for years of collaboration in mutual humanitarian tasks for the alleviation of human suffering and the greater understanding of men of all nations. This presentation was made on the occasion of the Centenary of the Canadian Red Cross Society. Acting Reeve Clark accepted the Certificate on behalf of the citizens of Burnaby.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR WELLS:  
"That the correspondence be received."

CARRIED UNANIMOUSLY

No. 637 Arrow Squadron, Royal Canadian Air Cadets, submitted an Invitation to the members of the Council to attend the Annual "Wings" Parade to be held Wednesday, October 23rd, at Burnaby Central Senior Secondary School.

Mr. C. P. West wrote regarding an application for subdivision of his property at the corner of Cliff Avenue and Halifax Street legally described Lot 7, D. L. 135, drawing attention to the fact that previously a natural drainage course traversed his property which had been enclosed by a culvert and that on application to subdivide he had been assessed the sum of \$3,800.00 to cover drainage costs. It was submitted by Mr. West that in view of the fact that the drainage course had been culverted previously and in view of certain other actions of the Municipality to divert the stream, the drainage costs should not be levied against him as a condition of subdivision approval.

Mr. E. C. Smith, neighbour of Mr. Percy West, wrote confirming that in years gone by a natural drainage course existed across the property of Mr. West which was enclosed by a wooden culvert. After coming under Cliff Avenue the drainage flowed through his property at 6955 Halifax Street. Due to subdivision in the area certain works had been undertaken to divert the natural water drainage from its former course to follow the street and lane pattern which subsequently was created through the subdivision process.

COUNCILLOR DRUMMOND ATTENDED AT 7:40 P.M.

It was submitted by His Worship the Reeve that Cliff Avenue had recently been paved and that if certain changes had been made to

the drainage and if the Municipality had recognized the drainage responsibility prior to the paving, then the Corporation should bear its share of the responsibility at this time. It was submitted that subdivision approval should be granted without costs for drainage from the focal point to the outlet point as affecting the West property.

MOVED BY COUNCILLOR CLARK, SECONDED BY COUNCILLOR WELLS:  
 "That the Council recognize its responsibility for conducting drainage from the focal point within the proposed subdivision of the C. P. West property to a proper point of outlet."

CARRIED UNANIMOUSLY

The Community Planning Association submitted congratulations to The Municipality for participating in a study of the site surrounding the Simon Fraser University.

The City of North Vancouver submitted a request that the Council endorse an approach to the Honourable George McIlraith, Minister of Transport for Canada, for improvements to the North Shore of the Vancouver Harbour.

Some reluctance to support the request of North Vancouver was expressed in view of the absence of full facts of the matter. It was also suggested that an association of municipalities in the Metropolitan area might be established to resolve some of the problems related to the Vancouver Harbour.

MOVED BY COUNCILLOR CLARK, SECONDED BY COUNCILLOR BLAIR:  
 "That this matter be tabled and the Clerk be instructed to forward a copy of the submission of the City of North Vancouver to the Minister of Transport for Canada with the request for comment by the Minister on his Department's position in this matter."

Your Committee met on Tuesday, October 15th, 1963 and recommends:

- (1) That the low bid of \$19,980.00 received from R. J. Whitlam, 4314 Ledger Street, Burnaby, for operation of the Sperling Avenue Garbage Dump for a period of one year, be accepted and that authority be granted for the Reeve and Clerk to execute the necessary contract in connection therewith.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR CLARK:  
"That the recommendation of the Committee be adopted."

- (2) That Mr. E. E. Olson be confirmed in the position of Municipal Engineer with this Corporation, effective October 15th, 1963.

CARRIED UNANIMOUSLY

His Worship, the Reeve submitted a report on Local Improvements in regard to the following:

- (1) Delta Avenue - It was reported that meetings had been held in Brentwood Elementary School with interested citizens on September 24th, along with Councillor Clark and a representative of the Engineering Department, and that in view of the acceptance by property owners in other parts of the Municipality of similar local improvements on streets comparable to Delta Avenue, special concessions could not be recommended in this instance. It was felt the explanation given to the citizens concerning the local improvement policy and the added fact that the chargeable depth to abutting owners had been reduced from 12 to 14 feet may result in a change of heart.

It was recommended that curb sidewalks with appropriate asphaltic widening be initiated on the west side of Delta Avenue from Brentlawn to Union Streets and on the east side from Halifax to Union Streets and that these be treated as separate projects.

It was further recommended that in the event of passage of either or both of the projects that priority be given to the completion of the work.

MOVED BY COUNCILLOR CLARK, SECONDED BY COUNCILLOR MacSORLEY:  
"That the recommendations of the Reeve be adopted."

CARRIED UNANIMOUSLY

- (2) 4400 Block Pender Street - It was reported that all blocks of Pender Street between Boundary Road and Willingdon Avenue have sidewalks with the exception of the 4400 Block where the only sidewalk is located for a short distance on the north side and abutting a super market parking lot. The local improvement calling for asphaltic widening plus concrete curbs had been successful with only one objection registered of the 28 eligible owners.

It was recommended that sidewalks be initiated for this block in order that such improvements can be carried out concurrently with the curbing and widening in the event of passage of the initiated work.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR DRUMMOND:  
"That the recommendation of the Reeve be adopted."

CARRIED UNANIMOUSLY

His Worship the Reeve reported on a meeting of the Executive of the Union of B. C. Municipalities in New Westminster on Friday, October 18th, to determine the dates for the next Convention of the Union to be held in Burnaby on September 23rd to 25th inclusive. It was now, therefore, appropriate to proceed with plans for hosting the event and it was recommended a Special Committee of the whole Council be appointed with the Reeve as Chairman. In this connection individual duties to be assigned as required. It was further recommended that the staff member for this task be Mr. Dennis Grant.

MOVED BY COUNCILLOR CLARK, SECONDED BY COUNCILLOR BLAIR:  
"That the recommendation of the Reeve be adopted."

CARRIED UNANIMOUSLY

His Worship the Reeve as Chairman of the Grants Committee, submitted the following recommendations:

Durnaby Players - It was recommended that a grant in the amount of \$100.00 be made.

It was reported that a grant is usually made to the Burnaby Players by the Parks and Recreation Commission.

Mr. Whitehouse submitted that he owns property as noted in the report extending from Edmonds Street to 19th Avenue and that the situation about which he was complaining had been put up with for a period of eight years. It was his submission that public services in the way of lane and sewer services were being supplied to commercial premises on Edmonds Street and 6th Street and that it was his opinion these services should be supplied by the Municipality. Mr. Whitehouse submitted that the reasons why he felt the Corporation should accept the responsibility of providing these services was that there is a long block between 6th and 8th Streets without lane provision at the present time and it was felt that if this block had been properly planned in the first instance, lane facilities would have been provided. At the present time garbage trucks use the road allowance over his property to service the commercial premises within the block. He, as owner of the property, was at liberty to close off access and to cut off the sewer connections to properties other than his own which were not covered by any easement agreement but he was reluctant to do so. The occupants of the other premises had asked that he do not disturb the services and for these reasons it is his opinion the Corporation should assist in resolving the matter.

"That the problems involved in this matter be referred to the Policy Committee for consideration."
