# DECEMBER 14. 1964

A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, December 14, 1964, at 7:30 p.m.

PRESENT: Acting Reeve Herd in the Chair; Councillors Blair, Cafferky, Dailly, Hicks and MacSorley.

ABSENT: Reeve A. H. Emmott and Councillor Edwards.

Reverend W. E. Lowe led in Opening Prayer.

Secretary, Burnaby Citizens Committee for Access to Burrard Inlet at Barnet Park, wrote requesting an opportunity to address Council on the matter of providing boat launching facilities in the Municipality.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR BLAIR: "That the delegation from the Committee mentioned be heard."

CARRIED UNANIMOUSLY

Mr. W. G. Wilson, Secretary of the Committee, appeared and `presented a number of resolutions passed by the Committee dealing with:

- The recent action taken by Council to share equally with the City of Port Moody the cost of providing boat launching facilities in the City.
- (2) The matter of Burnaby applying for a level crossing of the Canadian Pacific Railway at Barnet Beach.

Mr. Wilson elaborated on the resolutions and also proffered some recommendations concerning the development of Barnet Beach.

He also supplied an estimate of the cost of an overpass for the crossing of the Canadian Pacific Railway at Barnet Beach.

He stated that the Committee was primarily concerned with the matter of obtaining access to Barnet Beach and the subsequent development of the area to the North for recreational purposes. He remarked that the Committee is aware of the history in connection with this question of access and it naturally appreciates that the provision of such access will cost money.

The estimate furnished Council indicated that it would cost less than \$25,000.00 for the construction of a crossing structure over the Canadian Pacific Railway at Barnet Beach.

Acting Reeve Herd mentioned that the Committee in question had not appeared before the Parks and Recreation Commission in regard to the matter of concern to it. He also drew attention to the fact that Council was having a meeting with the Commission next Wednesday evening.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR HICKS: "That the submissions from the Burnaby Citizens Committee for Access to Burrard Inlet at Barnet Park be referred to the meeting between Council and the Commission next Wednesday evening for consideration in conjunction with other literary material that will be received then."

### CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR CAFFERKY: "That all of the below listed correspondence be received."

### CARRIED UNANIMOUSLY

Division Manager. Transportation. B.C. Hydro and Power Authority, submitted a letter advising that the Authority is of the opinion that the existing Westbound bus stop on Hastings Street nearside Boundary Road should be retained because it is not possible to establish a bus stop farside Boundary Road due to the presence of a sidewalk crossing within the area that would be required for the stop.

Attorncy-General for the Province of British Columbia wrote advising that his Department is endeavouring to secure some area of uniformity in the matter of establishing a speed limit in lanes before acting on a request that the Government seriously consider the introduction of permissive legislation that would grant municipalities the right to impose a speed limit in lanes without the prerequisite of erecting signs at the exit and entrance of every lane to indicate the speed limit.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR MacSORLEY: "That a letter be sent to the Attorney-General pointing out that the speed limit in lanes in Vancouver is currently 15 m.p.h. and therefore the question raised as to uniformity should not present a problem if identical legislation was introduced for all other municipalities in the Province."

#### CARRIED UNANIMOUSLY

<u>Minister of Municipal Affairs</u> submitted a letter indicating that the position of Council respecting the Winter Works policy of the Provincial Government has been noted.

Dr. Joseph T. Mandy submitted a letter commending Mr. G. Eyford and Mr. A. Evans of the Engineering Department for the manner in which they constructed underground and surface works on imperial Street adjacent Central Park.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR BLAIR: "That the commendation be conveyed to the two gentlemen concerned."

### CARRIED UNANIMOUSLY

Activities Chairman, The Burnaby-Hastings Junior Rotary Band, wrote seeking permission to hold a Bottle Drive on December 29th in the area bounded by Boundary Road, the North shore of the Municipality, Sperling Avenue and Georgia Street between the hours of 2:30 p.m. and 8:30 p.m.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR CAFFERKY: "That permission be granted to the Burnaby-Hastings Junior Rotary Band to conduct the Campaign described at the time mentioned and in the area outlined."

### CARRIED UNANIMOUSLY

<u>Mr. P. Beckmann, Barrister and Solicitor</u>, submitted a letter on behalf of Else Enterprises Limited applying for a licence to operate a discotheque club in the Municipality.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR BLAIR: "That a report be submitted by the Municipal Manager next Monday evening indicating:

- (1) From the R.C.M.P., the general character of the principals of Else Enterprises Limited, especially in relation to their operation in Victoria.
- (11) The attitude of the Burnaby School Board toward the proposed activity of the Company.
- (III) From the Planning Department, the situation respecting the proposed use of the land, including all attendant considerations (e.g. parking facilities, neighborhood amenities, etc.)

## CARRIED UNANIMOUSLY

Mr. Arnold F. C. Hean, Chairman of the Advisory Planning Commission, submitted a letter giving notice of his resignation as a member of the Commission, effective the date of the December meeting of the Commission.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR DAILLY: "That the resignation of Mr. Hean be accepted, with sincere regret."

In the deliberations on the project covered by "BURNABY LOCAL IMPROVEMENT CONSTRUCTION BY-LAW NO. 55, 1964" (20 foot pavement on portions of Kensington Avenue and Laurel Street), a question was raised as to why the Municipality would be proceeding with this work now when the Aldon Lodge Limited development proposal has yet to be finally decided. It was pointed out that this development would necessitate the provision of certain underground services and, because the location of the proposed development has not yet been determined, perhaps the paving project should await the resolution of this question involving the Aldon Lodge Limited proposal.

The Council directed that a report be submitted indicating the intentions of the Municipal Engineer with respect to the paving of the two Streets in question in view of the situation just described concerning the Aldon Lodge Limited proposal.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR MacSORLEY: "That "BURNABY LOCAL IMPROVEMENT CONSTRUCTION BY-LAW NO. 54, 1964" "BURNABY BUILDING BY-LAW 1964" be now reconsidered."
