# OCTOBER 19. 1964

A Regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, October 19, 1964 at 7:30 p.m.

PRESENT:

Acting Reeve Dailly in the chair; Councillors Blair, Cafferky, Herd, Hicks, Edwards and MacSorley.

ABSENT:

Reeve Emmott.

Reverend P. O. Hauge led in Opening Prayer.

Executive Secretary, Burnaby Community Chest Council, wrote requesting an opportunity to address Council in respect to it making a grant to the Community Chest Council.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR EDWARDS: "That the delegation from the Burnaby Community Chest Council be heard."

CARRIED UNANIMOUSLY

Mr. L. J. Costley, President of the Community Chest Council, appeared and requested that a grant in the same amount that was given last year be made to the Community Chest Council In support of its work.

He added that the Community Chest Council is pleased with the response that has been shown in Burnaby thus far in connection with the appeal for funds and mentioned that the sum of \$18,434.00 has been received to date.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR HERDA "That the request of the Burnaby Community Chest Council be referred to the Grants Committee for consideration and recommendation."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR HICKS: "That all of the below listed correspondence be received."

CARRIED UNANIMOUSLY

Mr. J. R. McMaster wrote requesting that consideration be given the enclosing of a ditch on the imperial Street side of his property at 6810 Macpherson Avenue.

It was indicated to Council that this matter had been referred to the Engineer and that a report from him was expected in time for the Council meeting next Monday evening.

Executive Secretary, Branch No. 148 of the Royal Canadian Legion, submitted two letters containing requests for permission to:

Hold an annual Remembrance Day Parade on November 11th commencing at 10:15 a.m. from the "Safeway" parking lot at Hastings Street and Rosser Avenue to the cenotaph in Confederation Park.

- (2) Hold a parade on November 3th commencing at 11 a.m. from Sperling Avenue and Hallfax Street to the Church.
- (3) Canvas in the North Burnaby area for the purpose of disposing of annual Remembrance Day popples on November 5th and 7th, 1954.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR BLAIR: "That permission be granted to Branch No. 146 of the Royal Canadian Legion to conduct the three activities described at the times mentioned, with the holding of the parades being subject to the approval of the R.C.M.P."

CARRIED UMANIMOUSLY

The following matters were then lifted from the table:

- (1) Tenders for the supply and delivery of Water Distribution Pipe.
- (2) City Status.
- (1) Tenders for the supply and delivery of Water Distribution Pipe

At the request of Council, the Municipal Engineer spoke and suggested that the Corporation purchase 50% of the pipe specified in the tender call from a supplier of cast iron pipe and the remaining 50% from a supplier of asbestos cement pipe. He hastened to add that he had actually not changed his original opinion with respect to the purchase of water distribution pipe but, in view of there being a number of uncertainties relating to the installation costs for the two classes of pipe, he was prepared to compromise and use the two types of pipe. The Engineer also stated that he would ensure that such installation costs for the two classes of pipe were measured in order to accurately determine the relative features of each. He also remarked that the manufacturer of cast iron pipe would be requested to provide research information on the epoxy lining aspect of the pipe.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR HICKS:
"That water distribution pipe of the lengths and sizes specified in the tender call that was issued for the supply and delivery of the said pipe be purchased from the lowest bidder in the category of cast iron pipe (The John Davidson Company) and to the second lowest bidder in the category of asbestos cement pipe (Canadian Johns-Manville Limited) on the basis of each of the two supplying 50% of the lengths requested in the tender call, provided each of the said bidders applies the same unit cost factor to each of the different lengths covered in the bid submitted to, and opened by, the Corporation on August 24th, 1964, for the supply and delivery of the pipe in question, with the actual details as to the amounts to be selected being left to the discretion of the Municipal Engineer and Purchasing Agent."

# (2) City Status

The Chairman of the Special Committee dealing with the question of the Municipality becoming a City presented a recent letter he had received from the Minister of Highways in which the Minister advised that:

- (i) The Department of Highways would recap Grandview-Douglas Highway before it was transferred to the Municipality.
- (ii) The Department would also complete the improvements presently underway on Hastings Street before transferring the Hastings-Barnet Highway to the Municipality, provided there was no delay in the additional right-of-way being provided. The portion known as Barnet Highway would become Burnaby's responsibility immediately.
- (iii) Kingsway would be transferred to Burnaby immediately and, if the Municipality decided to widen the section between Edmonds Street and Tenth Avenue, the Department of Highways would consider a request for financial assistance after estimates are available if this was in the near future.
- (iv) Both Lougheed Highway and Tenth Avenue would be transferred immediately.
- (v) Regarding North Road, the Department maintains its present offer to share the cost of reconstruction with Burnaby and the District of Coquitiam but this would expire in three years.
- (vi) Marine Drive would become Burnaby's responsibility entirely when transferred.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR BLAIR: "That the Council now resolve itself into Committee of the Whole."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR MacSORLEY: "That the motion made on October 13, 1964 regarding the adoption of the report on City Status be rescinded."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HICKS: "That the recommendations of the Committee under Item (1) on page 4 of its report be adopted."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUCILLOR EDWARDS: "That the Special Committee continue to negotiate on those matters covered under No. (2) of page 4 in the report."

His Worship, Reeve Emmott, submitted a report recommending that Mr. A. B. Stewart, 8306 Government Street, Burnaby 2, B.C., be appointed to serve the balance of the term held by Mr. G. A. Sutherland, which would have expired in January, 1966.

The Reeve commented that Mr. Stewart is a former President of the Lozells Recreation Association and has been for many years extremely active in Boy Scout work in the Municipality.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR BLAIR: "That the recommendation of the Reeve be adopted."
