There will be four team rooms, showers and toilets, roughed-in clubrooms, a manager's office, a general office, a concession, and a skate rental section plus a skate changing area. The ice surface of the Rink will be 80 x 180 feet and, below the ice, will be a concrete floor. A large door, 12 feet in height, will be located at the South end of the building adjacent the parking lot that now serves the Swimming Pool. The ice-making equipment will be located in the South-East corner of the building. As is known by Council, the funds available for the project are \$345,000.00 and the architects are confident that the project can be undertaken within this amount."

The Municipal Manager also offered a few remarks in connection with the matter at hand. In this regard, he stated that the tender call for the project was advertized by the Corporation last Friday and Saturday, with tenders being returnable on December 10, 1964 and a report to be made to Council on December 14, 1964. He mentioned that plans and specifications for the development are available at the office of the architect.

The Manager further stated that the Parks and Recreation Commission has approved the general concept for the development and that the plans and specifications will be constantly reviewed by staff of the Municipality.
