JULY 27, 1964

A Regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, July 27, 1964 at 7:30 p.m.

PRESENT: Reeve A. H. Emmott in the Chair; Councillors Dailly, Herd, Hicks, Edwards.

ABSENT Councillors MacSorley, Blair and Cafferky.

Reverend G. Struthers led in Opening Prayer.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HICKS: "That the Minutes of the meeting held July 13, 1964 be adopted as written and confirmed."

CARRIED UNANIMOUSLY

His Worship, Reeve Emmott, then presented Municipal Administration Diplomas from the University of British Columbia to the following employees:

the Municipal Treasurer, Mr. B.
McCafferty)

(2) Junior Diploma - Mr. Wm. R. Stricker.

Reeve Emmott also presented to Mr. McCafferty an award issued by the Canadian Federation of Mayors and Municipalities for the best 1964 annual financial publication report. He mentioned that this was the second time that this award had been won by Bernaby.

The Council was informed that Mr. Charles Redhead, Secretary of the Ambulance Employees' Union was present and desired an audience. MOVED BY COUNCILLOR EDWARDS, SECONDED BY HERD: "That Mr. Redhead be heard."

CARRIED UNANIMOUSLY

Mr. Redhead appeared and presented a Brief on behalf of Local 873 of the Canadian Union of Public Employees (Ambulance Employees Union) on the question of the Municipality subsidizing ambulance service.

The Drief recommended that this action be taken by Council, on the understanding that there would be public control of the service, for the following reasons:

- (1) The increased cost of providing ambulance service is justified and the subsidy will create employment.
- (2) Many people would be unable to pay the unsubsidized economic rate.
- (3) If people cannot pay for the service, the company cannot operate.
- (4) Civic Government has a responsibility to ensure availability of the service.
- (5) The service is fully equipped and competently staffed to provide adequate and efficient coverage of the Municipality as part of a centrally dispatched operation.

(6) The service would be provided at cost and rates would be subject to Municipal control.

Mr. Redhead also stated that he understood a similar request was being made of the Cities of Vancouver and New Westminster.

It was mentioned that the Council had before it a report of the Policy Committee and also a report of the Municipal Manager dealing with the question of ambulance service.

In view of this, action on the request of the Ambulance Employees' Union was deferred pending consideration of the two reports mentioned.

MOVED BY COUNCILLOR DAILLY, SECONDED BY COUNCILLOR EDWARDS: "That Councillors MacSorley, Blair and Cafferky be granted leave of absence from this meeting".

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR EDWARDS: "That all of the below listed correspondence be received".

CARRIED UNANIMOUSLY

Secretary-Treasurer, Fraser Valley Municipal Association, submitted a letter enclosing copies of submissions made to the Association concerning the subjects of "Unemployed Employables" and "Zoning".

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HERD: "That the submissions from the Fraser Valley Municipal Association be referred to the Policy Committee for further consideration.

CARRIED UNANIMOUSLY

Secretary, Central Park Committee, submitted a copy of a letter addressed to the Vancouver Board of Parks & Public Recreation advising it and other bodies concerned with the operation of Central Park of the fact that the Central Park Committee was alarmed that the Council of the City of Vancouver had reduced the City's share of the cost of maintaining the Park.

During the deliberations on the subject matter of the letter, a suggestion was made __the Burnaby Parks & Recreation Commission should perhaps meet with the Vancouver Board of Parks & Public Recreation to discuss plans for the future development of Central Park, including the question of the allocation of funds for the development and maintenance programme for the Park. It was added that the aim in this proposal would be to establish an understanding between the two Municipalities in regard to the allocation of funds for the operation of Central Park.

Secretary, Local No. 23, Burnaby Civic Employees' Union, wrote advising that the Union is now being serviced by the Canadian Union of Public Employees and that the National Field Representative .s Mr. Donald F. Crabbe, who would be acting on behalf of the Civic Employees Union in all matters involving the Union and the Corporation when it is felt his services may be required.

MOVED BY COUNCILLOR HICKS; SECONDED BY COUNCILLOR DAILLY: "That the advice contained in the letter from the Union be referred to the Municipal Manager for attention".

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HERD:

He stressed that the courtroom facilities were entirely inadequate and that every effort should be made to renovate the premises to provide more suitable quarters. In this regard, he stated that the Municipal Manager had been asked for a detailed account of the problem and, as a result, it was ascertained that the approximate cost of making the necessary changes would be between \$6,000.00 and \$7,000.00.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR EDWARDS: "That authority be granted to arrange for the construction of the Float shown on the sketch prepared by Challier Display Associates Ltd. and entitled "Float" No. 361, at a cost of \$2,700.00."

CARRIED UNANIMOUSLY

Councillor Herd displayed a sample of a crest that has been designed to be worn by Councillors attending the U.B.C.M. Convention this September.

Reeve Emmott also exhibited a sample crest that he had received.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HERD: "That the crest shown by Reeve Emmott, with a pseudo meple leaf motif in gold on navy blue be approved as the Municipal Crest".

CARRIED UNANIMOUSLY

Councillor Herd was asked to obtain a cost estimate for seven of the crests so that Council would know the expenditure that will be incurred in ordering the crests. It was added that Reeve Emmott already has a crest of the kind desired.
