# SEPTEMBER 28, 1964

An Adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, September 28, 1964 at 7:30 p.m.

PRESENT

ABSENT:

Councillor Blair

His Worship, Reeve Emmott, Introduced Fire Chief appointee, Mr. L. C. Auvache. He very briefly described the qualifications of Mr. Auvache and wished him the best in the discharge of his duties in the future.

Mr. Auvache acknowledged the Introduction given by the Reeve by expressing gratitude for the appointment as Fire Chief.

Reeve Emmott also asked Fire Chief Auvache to convey the appreciation of Council to those members of the Fire Department who served as drivers of the courtesy cars that were provided for the delegates attending the recent U.B.C.M. Convention.

Mr. William Turner of the Municipal Affairs Committee of the Communist Party (Burnaby) wrote requesting an opportunity to address Council in respect to the subject of a business tax.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR EDWARDS: "That Mr. Turner be heard."

CARRIED UNANIMOUSLY

Mr. Turner was not present so the matter of his appearance was deferred until later in the evening.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR DAILLY: "That all of the below listed correspondence be received."

CARRIED UNANIMOUSLY

Executive Secretary, Burnaby Chamber of Commerce, submitted a letter thanking Council for hearing the views of the Chamber relative to the subject of business taxation. The Executive Secretary reiterated that, though there were certain discrepancies in the Brief that was submitted on the subject to Council on September 14th, the basic premises expounded in the Brief are still valid.

MOVED BY COUNCILLOR DAILLY, SECONDED BY COUNCILLOR EDWARDS:
"That the letter from the Burnaby Chamber of Commerce be
referred to the Policy Committee for consideration in conjunction with all the submissions that have been made in connection with the business tax question when the matter is to be discussed by that Committee."

CARRIED UNANIMOUSLY

Mr. William Turner appeared and advised that he would be presenting a written submission tomorrow concerning the subject of a business tax. He explained that his Party had

not had an opportunity to prepare the submission in time for the meeting this evening but, notwithstanding, he was prepared to expound the view of the Party and confirm this in the written submission that is to be presented.

Mr. Turner stated that his Party was reaffirming the contentions made by it to Council on March 15, 1964 relative to the matter at hand because it is felt the large corporations and industrial concerns are in a position to absorb more of the tax load.

To illustrate the situation, Mr. Turner recited a number of assessment statistics relating to certain industries in the Municipality and concluded by urging that no further tax increases for residential property be considered by Council when adjusting to the situation that has developed as a result of the machinery tax being abolished.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR EDWARDS: "That Mr. Turner be thanked for his presentation and his submission be referred to the Policy Committee for consideration at the time the question of business taxation is to be discussed."

#### CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR DAILLY, SECONDED BY COUNCILLOR HICKS: "That the Council now resolve itself into Committee of the Whole."

#### CARRIED UNANIMOUSLY

The Municipal Clerk announced that the Municipal Hall would be open between 7:00 p.m. and 9:00 p.m. tomorrow evening and Wednesday evening to receive declarants as Resident Electors or Tenant Electors. He mentioned too that a letter had been received from the Gurnaby Citizens Association requesting that such an arrangement be implemented.

COUNCILLOR EDWARDS WITHDREW FROM THE MEETING.

The Special Committee appointed to consider the matter of ambulance services being provided in the Municipality submitted a report, a copy of which is attached to and forms a part of these Minutes, dealing with the matter.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR HICKS: "That the recommendations of the Committee be adopted."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR DAILLY: "That, notwithstanding the action just taken by Council which accepts a temporary contract contributing to the provision of ambulance service in Burnaby, the Council is still of the opinion that ambulance service is an adjunct to, and should be provided by

the Provincial Government under the auspices of the B. C. Hospital Insurance Service.

COUNCILLOR MacSORLEY - AGAINST

Secretary, Federated Legislative Council of the Elder Citizens Association of British Columbia, wrote advising of a charge that had been made for ambulance service and enquiring as to the action that Council proposes to take as a result of this charge.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CAFFERKY:
"That the Federated Legislative Council be advised of the action
just taken in respect to ambulance service, as detailed in the
last two resolutions."

CARRIED UNANIMOUSLY

COUNCILLOR EDWARDS RETURNED TO THE MEETING

Reeve Emmott stated that he had received a reply from Inspector F. L. Jeeves of the R.C.M.P. to an enquiry of Council as to whether police vehicles could be used to provide a quasi-ambulance service when deemed appropriate.

The Reeve advised that Inspector Jeeves had indicated it had never been the policy of the R.C.M.P. to transport injured persons when ambulance service is available. He added that, in such cases, one of the basic rules followed by the R.C.M.P. is that injured persons should only be removed by the most qualified personnel and by the most appropriate means.

In his letter to the Reeve, Inspector Jeeves concluded by advising that he could not agree there should be any change in the present policy respecting the transportation of injured persons but that, if requested, he would refer the matter to his headquarters for a ruling.

MOVED BY COUNCILLOR MacSORLEY, SECONDED BY COUNCILLOR CAFFERKY: "That the information conveyed by the Reeve be received."

CARRIED UNANIMOUSLY

Councillor Cafferky stated that he had been given to understand there was a backlog of 112 cases in the Magistrate's Court for Burnaby and, as a result, the docket for the Court was filled to December 1, 1964.

He suggested that Council should prevail upon the Attorney-General for the Province to expedite the appointment of a Magistrate to replace the late Mr. C. C. Bell.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR DAILLY: "That the question of accelerating the appointment of a Magistrate for the Burnaby Court be referred to Councillor Edwards as the liason with the Justice Department for appropriate action."

Councillor Cafferky introduced the matter of the fees being charged by the Municipality for the dumping by Commercial vehicles of garbage in the Stride Avenue dump. He explained that our fees are much less than those charged by other Municipalities in the area and, as a result, Commercial vehicles carrying refuse were gravitating toward our dump.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR HICKS: "That the by-law governing the levying of fees for the dumping of garbage be amended by changing the rate to:

- (a) \$5.00 for any Commercial vehicle over 1/2 ton and less than 3 tons,
- (b) \$7.50 for any Commercial vehicle over 3 tons.

and further, that the by-law also be amended to permit individual residents of the Municipality to dump free of charge at the Stride Avenue pit.
