An adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, April 12, 1965, at 7:30 p.m.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR BLAIR:
"That the Minutes of the meetings held March 22nd and 29, 1965,
be adopted as written and confirmed."

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR HERD:
"That all of the below listed correspondence be received,"

CARRIED UNANIMOUSLY

Mr. R. J. McFarlane wrote expressing an objection against a proposal to establish a major road to serve the Eastern side of the Simon Fraser University site.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR BLAIR:
"That action on this matter be deferred until consideration of Item 2
of the Municipal Manager's report later this evening."

CARRIED UNANIMOUSLY

Mr. R. Sebastian submitted a letter expressing appreciation for the steps taken by Council to abate the dust nuisance on Godwin Avenue between Sprott Street and the entrance to the Works Yard.

Mr. Ray A. Pitre submitted a letter objecting to Clause 6 (b) of the proposed Business Tax By-Law. He advised that this Clause is redundant and places an unfair responsibility for the policing of licensing and business tax matters on landlords and agents.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR DRUMMOND:
"That action on the matter of concern to Mr. Pitre be deferred until
the Business Tax By-Law comes before Council for consideration."

<u>President, Volvo Car Club of B.C.</u>, wrote requesting permission to hold a "Twin Sprint" on the parking lot of the Middlegate Shopping Centre on April 25th between the hours of 10:00 a.m. and 4:00 p.m.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CORSBIE:

'That permission be granted to the Volvo Car Club of B.C. to conduct
the activity mentioned at the time indicated, on the understanding that
the Club:

- (a) has received the approval of the Burnaby Detachment of the R.C.M.P.;
- (b) has public liability and property damage insurance in the all-inclusive amounts of \$400,000.00 indemnifying the Corporation;
- (c) that the activities of the Club will be in the nature of an obstacle course, with participants operating their motor-vehicles at low speeds;
- (d) that the noise resulting from the activities will be kept to a minimum.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR HICKS:
"That the Council now resolve itself into Committee of the Whole."

The following matters were then lifted from the table:

(1) Municipal Service Centre

The Municipal Manager displayed a plan illustrating the proposals being recommended by him (which were described in a report submitted to Council at a previous meeting) and explained in some detail the situation confronting the Municipality in connection with the operation of the Municipal Service Centre on the present site.

He pointed out that the Corporation does not really require all of the "Switzer" property, although the total anticipated cost of this acquisition was included in the estimate that was originally submitted.

He also mentioned that it is expected the Municipal Service Centre will have a further lifetime of approximately ten years and that therefore the matter of selecting another area for a site will be given attention.

The Manager stressed that the current proposal was not to expand the Municipal Service Centre operations but only to rearrange existing facilities on and near the site. He suggested that the plan now being proposed will result in the traffic problem on the residential streets in the area being relieved which, per se, will materially improve the situation being experienced by those residing in the area.

He stated that the cost of land acquisition to implement the improvements proposed was approximately \$32,000.00 and that it would cost another \$10,000.00 to make certain additions and improvements to the existing plant. He added that the amount of land that is felt should be acquired is approximately 1.6 acres.

The Manager also emphasized that the Corporation could not relocate any part of its stock in the Service Centre without removing the entire stores operation as this would result in a duplication of effort in trying to maintain two separate operations. He remarked that the cost of total relocation of the Municipal Service Centre would be approximately \$1,000,000,000.

His Worship, Reeve Emmott, stressed that the matter currently capturing the attention of Council is merely one of considering the rearrangement of existing facilities at the Municipal Service Centre.

He stated that he supported the proposal being advanced by the Manager and that, quite apart from this, the Corporation should do what is reasonably necessary to improve the appearance of the Service Centre,

A suggestion was made by a member of Council that the Municipality submit a question to the people involved enquiring as to whether they approve the proposal outlined in the report of the Municipal Manager.

Letters from Mr. and Mrs. R. V. Winter and Mary E. Saunders opposing the proposal involving the Municipal Service Centre were submitted, but not read, to Council.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CORSBIE:
"That the Municipal Service Centre proposal be tabled for a period of
one week in order to allow each member of Council an opportunity to
visit the site in company with appropriate officials to determine more
precisely the current problems and the solution being recommended."

Municipal Clerk read a letter from the Municipal Solicitor in which the latter advised that the Burnaby Week Committee may only hold a Bingo game if the Committee can be classed as a religious or charitable organization. The Solicitor added that he was not aware of the opinion of the Attorney-General's Office but he felt the Committee was neither of the two types of organization mentioned.

The Solicitor drew attention to the fact that, if the game was held in Central Park, the terms of the Central Park lease would need to be also considered. The pertinent section to which he made reference in his letter was that which read "the Park shall be used as a public park and pleasure ground for the recreation and enjoyment of the public and for no other purposes". The Solicitor remarked that some might say the playing of Bingo does not come within this clause.

It was mentioned that a traffic problem exists on North Road in the vicinity of Lougheed Highway and Government Street that is caused by movements to and from the shopping complex in the area.

The Municipal Engineer indicated that this matter would be given attention during current considerations of improvements to North Road.

"WHEREAS the Government of Canada in August 1963 by Bill C76 set up a Municipal Development Loan Fund totalling Four hundred million dollars, thereby enabling municipalities upon approval of capital projects by their provinces to borrow at rates of interest ordinarily payable by the Government of Canada for long term money, two-thirds of the cost of said projects with a forgiveness of one quarter of the loan on proportion of work completed by 31 March, 1966.

AND WHEREAS the forgiveness feature of the Act resulted in low cost money to the municipalities

AND WHEREAS this enabled municipalities to undertake much-needed works that could otherwise not have been undertaken

AND WHEREAS there is a backlog of other needed works in municipalities

AND WHEREAS the Four hundred million dollars have now been allocated for specific works

THEREFORE be it resolved that the Government of Canada be asked to extend the provisions of Bill C76 for a further three years and made a further allocation of funds."

The Manager stated that this resolution was sent to the Federation before being approved by Council because of the time limit that had been placed on the submission of resolutions for the Conference this May.

He read a letter from the Executive Director of the Canadian Federation of Mayors and Municipalities acknowledging receipt of the subject resolution and advising that it would be included in the final compendium of resolutions for the Conference in Windsor, Ontario, in May, 1965.
