A regular meeting of the Municipal Council was held in the Council Chamber, Municipal Hall, 4545 East Grandview-Douglas Highway, on Monday, March 22, 1965, at 7:30 p.m.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR HERD:
"That all of the below listed correspondence be received."

CARRIED UNANIMOUSLY

<u>Secretary-Treasurer</u>, <u>Fraser Valley Municipal Association</u>, submitted advice of the next meeting of the Association on April 1st in the City Hail, City of Port Coquitlam, at 8:00 p.m.

It was understood that as many members of Council as possible would endeavour to attend the meeting of the Association.

Minister of Municipal Affairs submitted a circular letter inviting officers of the Corporation to attend the Annual Conference of the British Columbia Municipal Officers' Association in Victoria on May 31st, June 1 and 2, 1965.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR DAILLY:
"That this letter be referred to the Municipal Manager for consideration and recommendation."

The Vice-President requested that, if this materializes, the Municipality lend its support to the Branch in staging the Convention.

<u>Principal</u>, <u>Burnaby North Secondary School</u>, wrote requesting permission to hold a Parade on April 3rd commencing at 1:30 p.m. from Boundary Road and Hastings Street, thence along this Street to Delta Avenue, thence South on Delta Avenue to the Brentwood Shopping Centre and returning via Willingdon Avenue to Hastings Street and then East on Hastings Street to Hammarskjold Drive.

Municipalities</u>, submitted a circular letter enclosing a copy of an interim report from the Special Municipal Advisory Committee on pensions containing its observations at this time with respect to certain facets of the Municipal Superannuation Scheme and its relationship with the proposed Canada Pension Plan.

Executive Director, Lower Mainland Regional Planning Board, submitted a letter advising that the requisite number of Municipal Councils have approved the 1965 Budget of the Board that was adopted by it on January 21, 1965.

- (e) That, if deemed acceptable by the Corporation, the wire fencing that is to be placed around the property be allowed to remain after the expiry date of the lease for as long a period as may be determined by the Corporation.
