A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, November 22, 1965, at 7:30 p.m.

Reverend W. E. Lowe led in Opening Prayer.

The Burnaby Art Society wrote requesting an opportunity to present a Brief respecting the future of a public art gallery in the municipality.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR HICKS: "That the delegation from the Society be heard."

CARRIED UNANIMOUSLY

Mrs. George A. Whiten, President, Burnaby Art Society, appeared and read the Brief from the Society which contained a number of proposals relating to the future of the Burnaby Public Art Gallery.

The Brief requested that the following points in connection with the matter at hand be considered by Council:

- (1) That the present exhibiting resources of the Burnaby Art Society be transferred to the municipality.
- (2) That a permanent art gallery be constituted and be known as the Burnaby Public Art Gallery.
- (3) That the Gallery be financed and administered on certain principles outlined in the Brief.
- (4) That the Gallery be governed by a seven-man Board, to be appointed by Council and to hold office on a limited term basis, composed of one representative from the Council, two representatives from the Burnaby Art Gallery Society, one representative from the Burnaby Art Teachers' Association, and three members from the community at large. In addition, an Executive Secretary should be appointed to serve the Board.

Mrs. Whiten also elaborated on certain aspects of the Brief and answered a number of questions that were posed by members of Council in regard to the proposal in the Brief.

"That the submission from the Burnaby Art Society be referred to the
Policy/Planning Committee for full consideration and representatives
from the Society be invited to attend the meeting of the Committee when
the Brief is to be deliberated; and further, that the Municipal Manager
arrange to furnish all pertinent data the municipality may presently have,
or can obtain, on the activities of the Society in order for the Committee

to be fully apprized of the ramifications associated with the proposals in the Brief."

While deliberating the request of Mr. Gregson, it was pointed out that it would be most imprudent for Council to attempt to influence the decision of the Approving Officer because such action could establish a precedent which would have the effect of permitting all subdividers who may be aggrieved by a decision of the Approving Officer an opportunity to appeal this decision to Council.
