OCTOBER 25, 1965

A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, October 25, 1965, at 7:30 p.m.

PRESENT:

Reeve Emmott in the Chair; Councillors Blair (7:32 p.m.),

Cafferky, Corsbie, Dailly (7:32 p.m.),

Drummond, Edwards (7:32 p.m.), Herd and Hicks (7:40 p.m.)

Monseigneur J. E. Brown led in Opening Prayer.

His Worship, Reeve Emmott, proclaimed the period between and including November 1st and November 10, 1965, as Poppy Week.

COUNCILLORS BLAIR, DAILLY AND EDWARDS ARRIVED AT THE MEETING.

His Worship, Reeve Emmott, then introduced a contingency from the First Burnaby Land Rangers and welcomed them to the meeting.

For their benefit and that of everyone else assembled, the Reeve described Democracy and the function of all levels of Government in Canada.

MOVED BY COUNCILLOR CORSBIE, SECONDED BY COUNCILLOR HERD:
"That the Minutes of the meeting held September 20, 1965, be adopted as written and confirmed."

CARRIED UNANIMOUSLY

Mr. and Mrs. W. A. Barker wrote requesting relief from the servicing costs associated with a proposed subdivision of Lot 14 except South 165 feet, Block 6, D.L. 745½, Plan 1856.

it was mentioned to Council that Mr. Barker wished to address it.

it was also pointed out that Item 8 of the Municipal Manager's report this evening dealt with the matter of concern to Mr. and Mrs. Barker.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR CORSBIE: "That Mr. Barker be heard and Item 8 of the Municipal Manager's Report No. 74, 1965, be brought forward."

CARRIED UNANIMOUSLY

The Municipal Clerk explained that Mr. Barker was not able to attend at this time but would likely be present later in the evening.

As a result, the Council deferred consideration of the request from Mr. and Mrs. Barker until one of them appeared.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR DAILLY: "That all of the below listed correspondence be received."

ecretary, Local No. 23, Burnaby Civic Employees' Union, submitted a letter advising that the Union wishes to re-open the agreements with the Corporation and the various Divisions of the Union.

MOVED BY COUNCILLOR CORSBIE, SECONDED BY COUNCILLOR HERD:
"That the matter mentioned in the latter from the Burnaby Civic Employees'
Union (Local No. 23) be referred to the Municipal Manager to make the
necessary arrangements for negotiations with the Union."

CARRIED UNANIMOUSLY

Executive Secretary, Burnaby Community Chest Council, wrote expressing appreciation for the grant of \$1,000.00 which was made to assist the Community Chest Council in a survey of health, welfare and recreation needs in Burnaby.

COUNCILLOR HICKS ARRIVED AT THE MEETING.

Mr. J. B. Nesbitt of the "Totem Motel" submitted a letter expressing an objection to the proposed rezoning of Parcel "C", Reference Plan 15235, except Explanatory Plan 16419, S.D. "B" and 20, Blocks 4/5, D.L. 125, Plans 3347 and 3520, to Multiple Family Residential District One (RMI) because this would make the existing facilities of the parcel (the "Totem Motel") non-conforming and would thereby preclude any expansion of the motel operation.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR CAFFERKY:
"That action on the request of Mr. Nesbitt be deferred until the
amendment to "Burnaby Zoning By-Law 1965" covering the rezoning in
question is further considered."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR EDWARDS:
"That the Council now resolve itself into Committee of the Whole."

CARRIED UNANIMOUSLY

His Worship, Reeve Emmott, submitted a report recommending that Councillor V.A. Blair be appointed as Acting Reeve for the months of November and December, 1965.

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR EDWARDS: "That the recommendation of the Reeve be adopted."

His Worship, Reeve Emmott, stated that a meeting had been arranged for Wednesday, November 10, 1965, at 10:00 a.m., with the Deputy Minister of Municipal Affairs, Mr. J. E. Brown, and the Supervisor of the B.C. Region, Central Mortgage and Housing Corporation, Mr. R. G. Clauson, to discuss the plan of the Municipality involving the redevelopment of the 3800 and 3900 Blocks Hastings Street.

it was understood by Council that the North Burnaby Commerce and Community Bureau would be advised of this meeting.

(3) Application for Welfare Institutions Licence (WARDROP_ 3588 Smith Avenue)

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR HICKS: "That the application be approved on the basis outlined in the report."

CARRIED UNANIMOUSLY

(4) Supplement to Stage 2 of the Local Improvement Programme

MOVED BY COUNCILLOR CAFFERKY, SECONDED BY COUNCILLOR HICKS: "That the recommendation of the Manager be adopted."

CARRIED UNANIMOUSLY

(5) Proposed Group Home for Children (ASHWORTH, 5757 Willingdon Avenue)

MOVED BY COUNCILLOR DRUMMOND, SECONDED BY COUNCILLOR EDWARDS:
"That the application in question be approved on the basis outlined in
the report,"

(6) Buckingham Avenue from Sperling Avenue to Burris Street

While considering the subject matter of the report from the Manager, it was noted that concurrence with the view expressed therein would have the effect of introducing a change in the policy of the Corporation governing Local Improvements.

The Council felt that, due to the rather unusual circumstances involving improvements to the subject portion of Buckingham Avenue, there was justification in instituting the two-thirds/one-third cost sharing arrangement outlined in the report.

It was also the view of Council that, though it may be practical to construct a concrete sidewalk on both the North side of Buckingham Avenue between Sperling Avenue and Burris Street and also the South side of Buckingham Avenue from Sperling Avenue to Hazard Street, it would be inadvisable to do so.

MOVED BY COUNCILLOR DRUMMOND, SECONDED BY COUNCILLOR CORSBIE:
"That the direction issued by Council on October 4, 1965, involving
the construction of a 4-foot wide concrete sidewalk on the North side
of Buckingham Avenue between Sperling Avenue and Burris Street as a
Local Improvement be amended by requiring that those owners directly
abutting the work pay two-thirds of the owners' share of the cost
and those on the South side of the Street paying one-third of this cost."

CARRIED UNANIMOUSLY

(7) Buller Avenue between Kingsway and Beresford Street

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR CAFFERKY: "That the recommendations of the Manager be adopted."

(8) Servicing Costs related to the proposed subdivision of Lot 14 except South 165 feet, Block 6, D.L. 7482, Plan 5816 (BARKER)

It was noted that Mr. Barker was now in attendance and, in accordance with the resolution passed by Council earlier this evening, he was granted permission to speak.

Mr. Barker stated that he had been before Council on past occasions with respect to his protest against the subdivision servicing costs related to the subject property and had not met with success.

He pointed out that he felt the costs involved were excessive and that Council should ask the Approving Officer to reduce them.

Mr. Barker mentioned that permits were issued a few years ago to construct two homes on the property in question and that this act should be treated by Council as implying it was aware the property would likely be subdivided at some time in the future.

He advised that the Approving Officer has indicated that the costs of constructing roads, lanes and a water supply in connection with the subdivision were \$4,200.00, which figure is for 330 feet of road.

Mr. Barker contended that, since only 172 feet of his frontage will be served by the road, he should only need to pay for this length. He also pointed out that it is planned for the future to create a cul-de-sac at the end of the street which is now proposed to be established.

With respect to the comment in the report of the Municipal Manager concerning Mr. Justice MacLean dismissing the appeal of Mr. Barker in 1960 against the decision of the Approving Officer to not approve a subdivision plan of the subject property unless the then servicing costs were deposited with the Municipality, Mr. Barker claimed that his lawyer had informed him the appeal was never heard because it was out of time.

It was pointed out to Council in discussion that, apart from the fact that acceding to the request of Mr. Barker would establish a precedent that might prove costly to the Municipality in the future, the Corporation really only has two alternatives, they being:

- (a) to either lower the standard of services to the property involved, or
- (b) the Municipality itself accepting part of the servicing costs.

The remark was made that the first alternative was virtually impossible because only a minimum standard of services is being required, while the second would be imprudent because it would in effect mean that the tax payers of Burnaby would be subsidizing the cost of Mr. Barker servicing his property.

Executive Assistant to the Municipal Manager reported verbally that information had just been received that the area in which the property of Mr. Barker is located is due to be served by sewer and storm drainage facilities, with the result the total servicing costs against the subdivision at hand will be \$4,200.00 at this time rather than \$6,000.00 - the amount indicated in the report of the Manager.

MOVED BY COUNCILLOR EDWARDS, SECONDED BY COUNCILLOR DAILLY:
"That the request of Mr. Barker for relief from the servicing costs
associated with a proposed subdivision of the subject Lot 14 not be
entertained because it is felt this would establish a precedent which
might prove costly to the Municipality in the future."
