APRIL 26, 1965

An adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, April 26, 1965, at 7:30 p.m.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR DAILLY: "That the Minutes of the meetings held April 12th and 20, 1965, be adopted as written and confirmed."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR BLAIR: "That all of the below listed correspondence be received."

CARRIED UNANIMOUSLY

Secretary, Greater Vancouver Water District, wrote advising that the Administration Board of the Greater Vancouver Water District has authorized the undertaking of that work requested by Council on March 22, 1965, relating to the provision of water service to the Simon Fraser University site.

Secretary, Kiwanis Club of North Burnaby, submitted a letter complaining that the Simon Fraser University development has resulted in the destruction of virtually all of the work that was carried out by the Club in developing a picnic and barbecue site on Burnaby Mountain.

MOVED BY COUNCILLOR CORSBIE, SECONDED BY COUNCILLOR DAILLY:
"That consideration of this matter be deferred until Item 8 of the Municipal Manager's report later this evening."

CARRIED UNANIMOUSLY

Executive Director, Union of B.C. Municipalities, submitted a circular advising that the 1965 Convention of the Union will be held in Victoria between September 22nd and 24, 1965, inclusive.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR DAILLY:
"That the Council now resolve itself into Committee of the Whole."

CARRIED UNANIMOUSLY

The following matters were then lifted from the table:

(a) Proposal of Norburn Construction Company Limited re
Charles Street from Kensington Avenue to the W.P.L. of
Lot 51, D.L. 129, Plan 19045 (tabled from April 20th meeting)

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR CORSBIE:
"That further consideration of this matter be deferred until receipt of
Items 10 and 12 of the Municipal Manager's report later this evening."

CARRIED UNANTHOUSLY

(b) Municipal Service Centre (tabled from April 20th meeting)

Executive Assistant to the Municipal Manager stated that a thorough search of the Planning Department files was made and no letter found in which a statement was made that the Municipal Service Centre would be relocated within five years from 1960.

Letters from Mrs. Mary E. Saunders, c/o Montague B. Saunders, and Mr. and Mrs. R. B. Winter were brought forward.

Both of these letters expressed opposition to the proposal of the Municipality regarding the Municipal Service Centre.

In the letter from Mrs. Saunders, she indicated that she would not willingly sell any part of her property for the Municipal Service Centre development.

His Worship, Reeve Emmott pointed out that he was not aware where Mrs. Saunders received the impression that the Municipality was interested in acquiring her property as this has never been indicated in any report that has been received by Council.

He stated that there was no intention on the part of the Corporation to acquire her property for the purpose earlier mentioned.

MOVED BY COUNCILLOR DAILLY, SECONDED BY COUNCILLOR HERD:
"That the recommendation contained in a report of the Manager dated
March 8, 1965, dealing with the Municipal Service Centre be adopted, on
the understanding that, if the Municipality is successful in obtaining
the part of the Lot "A" described in the report that is actually needed,
the part purchase will be made but, if the owner demands that the Corporation
purchase the entire parcel, then the Municipality will likely acquire the
whole."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR DAILLY:
"That a development plan, including beautification of the site of the
Service Centre, and a more detailed estimate of the cost of the total
project be submitted as soon as possible."

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR CORSBIE:
"That the matter of eventually relocating the Municipal Service Centre
be referred to the Policy Committee for further consideration."

CARRIED UNANIMOUSLY

It was understood that the matter of arranging a system of travel for employees of the Corporation operating from the Service Centre would also be given some attention by the Municipal Engineer.

The Municipal Manager stated that the Parks Department had been asked to produce a scheme for beautifying the area behind the Municipal Hall cutto Gilpin Street as a Winter Works project for the 1965-66 season.

He suggested that the work mentioned in the previous paragraph could perhaps be carried out now and any other improvements resulting from the scheme of the Parks Department could be undertaken during the next Winter Works programme.

(5) Encroachment on private land by Municipal Winter Works crews

His Worship, Reeve Emmott, stated that he had written to a Solicitor representing one of the owners involved in the subject matter of the report and explained the position of the Corporation in respect of the matter. He added that the Land Agent would soon be contacting the owner regarding the acquisition of the property by the Corporation.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR DAILLY: "That the report of the Manager be received."

(6) Grievance of Mr. Robert B. Miller

(8) Picnic and Barbecue Site on Burnaby Mountain (Kiwanis Club of North Burnaby)

The letter from the Kiwanis Club of North Burnaby, reference to which will be found earlier in these Minutes, was brought forward.

It was understood by Council that the Parks and Recreation Commission would determine whether the facilities that had been provided by the Kiwanis Club of North Burnaby should be replaced elsewhere in the Park or, if it is felt the value of the facilities was not appreciable and/or they should not be reinstated, then consideration should be given the matter of recompersing the Club for its efforts in developing the Picnic and Barbecue Site.

The letter also mentioned that Simpsons-Sears Limited would provide some landscaping on the area if its request was granted.

It was explained to Council that the reason for this request was that, while the present Town Planning By-Law permits a parking lot in a Commercial zone, the future expected zoning for the land will not and the fear of Simpsons-Sears Limited is that the land may not be ready for use as a parking lot by the time the new Zoning By-Law is implemented.
