## JUNE 28, 1965

A regular meeting of the Municipal Council was in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, June 28, 1965, at 7:30 p.m.

Reverend Archibald Carmichael led in Opening Prayer.

MOVED BY COUNCILLOR BLAIR, SECONDED BY COUNCILLOR HICKS: "That the Minutes of the meeting held on May 31st be adopted as written."

Mrs. S. Fisher submitted a letter asking whether it was the plan of the Council to press for public transportation past the C. G. Brown Memorial Pool and the Skating Rink. Mrs. Fisher also felt that a route running North and South on Sperling Avenue was needed.

## REPORT OF THE POLICY/PLANNING COMMITTEE -- RE AMBULANCE SERVICE

His Worship, the Reeve reported on behalf of the Policy/Planning Committee, on a meeting of the Committee held earlier in the day, when a delegation was received from the Ambulance Employees' Union (Local 873) and a discussion took place with regard to ambulance services. The Ambulance Employees' Union advised of plans to extend the subsidy equal to that currently made by municipalities of the metropolitan area, for a further ten days beyond the established deadline of June 30, 1965, to allow for the submission of a cost sharing proposal to the Provincial Government. The subsidy was to have been taken from Union funds and your Committee feels this is an unjust use of Union funds and recommends that the current subsidy be extended for a period of 30 days beyond June 30th, provided the Cities of Vancouver and New Westminster take similar action.
