### MARCH 29, 1965

An adjourned meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, B.C., on Monday, March 29, 1965, at 7:30 p.m.

His Worship, Reeve Emmott, issued the following Proclamation related to "Chamber of Commerce" Week:

"WHEREAS Burnaby does benefit from vigorous but friendly and ethical business competition locally, regionally, provincially and nationally;

AND WHEREAS Burnaby does prosper from the influx and expansion of commerce and industry, the growth of tourism and the provision of civic improvements in all respects including better educational, health and recreational facilities;

AND WHEREAS the Burnaby Chamber of Commerce is an important voluntary organization striving towards the attainment of these goals;

I HEREBY PROCLAIM the period April 4th - 10th, 1965, Chamber of Commerce Week; and in so doing urge all our citizens to encourage and to assist this body in furthering the development of our Municipality in an orderly and progressive fashion for the good of all."

His Wership, Reeve Emmott, also proclaimed the week of April 4th to 10th, 1965 inclusive, as "Salvation Army" Week.

The Proclamation was as follows:

"Because of the meritorious service rendered by The Salvation Army in Burnaby, and throughout the world, this Council extends, through Commissioner Edgar Grinsted, the Territorial Commander of The Salvation Army forces throughout the Dominion of Canada and the Isle of Bermuda, its appreciation for the noteworthy contribution made by The Salvation Army to the moral and spiritual development of the citizens of this Municipality and recognizes that the Army has pursued a course of practical Christian service in all areas of social welfare and spiritual need, thereby ameliorating suffering, want and despair."

Assistant Deputy Minister of Finance submitted a letter indicating the position of the Provincial Government with respect to an appeal of Mrs. F. D. Hurford for an allowance of the 1964 Home-owner's Grant on property described as Lot 20, Block 17, D.L. 187, Plan 1282.

in its letter, the Department of Finance advised that it is not possible to allow the application of Mrs. Hurford because it was not deposited by December 31, 1964.

MOVED BY COUNCILLOR CORSBIE, SECONDED BY COUNCILLOR DAILLY: "That a copy of the letter from the Department of Finance be sent to Mrs. Hurford so that she may be fully apprized of the situation involving her request."

<u>Secretary-Treasurer</u>, <u>Norburn Athletic Club</u>, submitted a letter applying for permission to hold Tag Days on either May 14th and 15, 1965, or April 16th and 17, 1965.

Councillor Dailly, as Chairman of the Burnaby Birthday Week Committee, apprized Council of a proposal of the Committee to conduct a carnival in Central Park or Bonsor Park at the termination of a Parade that is to be held later this year.

He advised that it is understood application must be made to the Attorney-General to hold the carnival since it is possible the Committee may wish to arrange for the public to play Bingo and other similar games at the carnival.

it was felt that the opinion of the Municipal Solicitor should first be sought on the proposal of the Burnaby Birthday Week Committee before approaching the Attorney-General for permission to conduct the various activities planned for the carnival.

"That Council express its appreciation to the members of the Planning

# FROM RESIDENTIAL TWO-FAMILY TO COMMERCIAL

Lot 4, Block 53, D.L. 30, Plan 3036 (Located on the South side of Kingsway approximately 305 feet East of Britton Street).

Planning Director submitted a letter confirming that which was indicated in his initial report on this proposed rezoning; namely, that the use proposed by the applicant does not logically come within a Commercial zone and should be confined to Light Industrial zones.

During discussion on the subject of whether an engine rebuilding business was a permissible use in a Commercial zone, attention was drawn to the fact that there are many other similar establishments in other Commercial zones in the Eunicipality that were likely allowed after the pertinent provisions of the "Town Planning By-Law" were enacted. A question arose as to why the use proposed for the subject Lot 4 is not now considered to be permissible under Commercial zoning when other uses that are ostensibly the same have been permitted in Commercial zones during the past year.

"That the Municipal Solicitor submit an opinion on whether or not the
use planned by the applicant for the rezoning of Lot 4, Block 53, D.L. 30,
Plan 3036 is an allowable one under the Commercial zone in the "Town Planning
By-Law!.

It was understood that, in replying to the letter from Mr. Celli, the following should be pointed out to him:

- (a) Contrary to the remark made by Mr. Celli that the lane allowance East from Gilley Avenue between Neville Street and Clinton Street was not closed two years ago because Council felt it was required in order to provide access for pedestrian traffic, the Council instead actually decided to not oppose an application of the property owners abutting the lane allowance to close it under Plans Cancellation Act proceedings.
- (b) With respect to the remark concerning an approach being made by the residents represented by Mr. Celli to the Department of Municipal Affairs in the event the lane allowance question is closed, there is always recourse to that Department by anyone who feels aggrieved by a decision of Council and therefore, if the citizens involved desire to take this action, then this is their prerogative.
- (c) Regarding the suggestion that a poll of the residents involved be made by Council before effecting the closure of the lane, this is not the method employed in attempting to resolve a matter such as the one at hand because Council has, in its employ, technical staff who are qualified to advise on a matter of this sort and, though the Council is naturally not obligated to accept such advice, it should always very carefully weigh the recommendations made by the staff before arriving at a decision.
