SEPTEMBER 6, 1966

A regular meeting of the Municipal Council was held in the Council Chambers, Municipal Hall, 4545 East Grandview-Douglas Highway, Burnaby 2, 8.C., on Tuesday, September 6, 1966, at 7:30 p.m.

Reverend T. L. Hipp led In Opening Prayer.

His Worship, Reeve Emmott, proclaimed the period between September 5th and September 10, 1966, as UNION LABEL WEEK.

His Worship, Reeve Emmott, Introduced ex Sergeant H. E. Klick of the R.C.M.P. and presented him with a set of cuff-links and a tie-bar in recognition of his past service for the Municipality as the Officer-in-Charge of the Traffic Detail of the R.C.M.P.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR DAILLY:
"That the Minutes of the adjourned meeting held on August 22, 1966, at
5:30 p.m. be adopted as written and confirmed."

CARRIED UNANIMOUSLY

MCVED BY COUNCILLOR McLEAN, SECONDED BY COUNCILLOR HICKS:
"That Councillors Cafferky, Corsbie and Dlair be granted leave of absence
from this meeting,"

CARRIED UNANIMOUSLY

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR McLEAN: "That all of the below listed correspondence be received."

CARRIED UNANIMOUSLY

<u>Secretary-Treasurer</u>, <u>Burnaby Fire Fighters' Association</u>, wrote requesting permission to hold a Collection Campaign for the Muscular Dystrophy Association of Canada during the week of November 6th to November 12, 1966.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR McLEAN:
"That permission be granted to the Association to conduct the Campaign
during the time mentioned."

CARRIED UNANIMOUSLY

Executive Director, Lower Mainland Regional Planning Board, submitted a letter advising that the Official Regional Plan has been approved by the Lieutenant Governor-in-Council.

He also mentioned that staff from the Board are in the process of making studies that are consequent upon the adoption of the Plan.

Administrator, Burnaby General Hospital, wrote requesting that the question of the Municipality borrowing for a building expansion programme for the Burnaby General Hospital be deferred until the Council meeting to be held on September 19, 1966.

The following motion was then lifted from the table:

"That a by-law be introduced for presentation to the electorate between October 15th and December 1st, 1966, authorizing a borrowing of \$6,325,400.00 for constructing and equipping an addition to Burnaby General Hospital, in accordance with plans and costs outlined in a Brief of the Burnaby Hospital Board, dated August 8, 1966."

His Morship, Reeve Emmott, outlined that which had occurred since the last meeting of Council in connection with the subject matter. In this regard, he stated that he had met with representatives from the Burnaby General Hospital to discuss all facets of the borrowing proposal. He added that a meeting was subsequently held with members of Council, the Municipal Manager, the Deputy Minister of Municipal Affairs, the Architect who has been retained by the Hospital Doard, and a representative from Pemberton Securities Limited, to discuss the financial aspects of the matter.

His Worship pointed out that it had been mentioned that there is legislation in Ontario where the Province bears two-thirds of the total cost of operating and constructing hospitals. He suggested that it was now opportune for local government in B.C. to press the Provincial Government for similar legislation, or at least a change in the prevailing formula for hospital costs. He added that it was also mentioned that it would be desirable for the Provincial Government to establish a financing authority in connection with hospital construction, a point that is to be brought to the attention of all Hospital Boards in the Province.

His Worship, Reeve Emmott, advised that, in his opinion, he felt that if the electorate of Burnaby approved the measure which has been advanced by the Hospital Board to Council, it would be difficult to obtain a change in the formula mentioned earlier. He pointed out that he had written to Premier W. A. C. Bennett to enquire as to his position on the matter.

His Worship also commented that there are several resolutions going to the U.D.C.M. Convention which undoubtedly will receive considerable deliberation.

His Worship concluded by stating that he felt the Municipality was in no position at all to borrow the money desired by the Burnaby General Hospital.

He suggested that Council establish a Special Committee to meet with representatives from the Hospital Board to further pursue the subject at hand.

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR HERD:
"That a Special Committee be established, with His Worship, the Reeve,
being given power to appoint the Committee."

CARRIED UNANIMOUSLY

His Worship, Reeve Emmott, then appointed himself as Chairman of the Special Committee, with Councillors Dlair, Drummond and McLean as members.

<u>Secretary, Burnaby Lake Aquatic Club</u>, submitted a letter expressing appreciation for the financial assistance given by Council to the members of the Burnaby Lake Aquatic Club who competed in the 84th Regatta of the Canadlan Association of Amateur Oarsmen.

He also expressed remarks concerning the success of the four-oared crew from the Club and the future plans of the Club.

Mr. W. A. Lawson of the "Walkathon" Committee of the Burnaby Citizen's Association, submitted a letter requesting permission to hold a "Walkathon" at 1:00 p.m. on September 17th, commencing at Confederation Park, thence South to Albert Street, West to Boundary Road, North to Eton Street, East to Willingdon Avenue, South to Persance Drive, East to Gamma Avenue, South to Empire Drive, Easterly to Sea Avenue, North to Dundas Street, East to Warwick Avenue, South to Rastings Street, West to Willingdon Avenue, and then North to Confederation Park.

MOVED BY COUNCILLOR MERD, SECONDED BY COUNCILLOR McLEAN:
"That permission be granted to the Association to conduct the activity
mentioned along the route described at the time indicated, subject to
the approval of the R.C.N.P."

CARRIED UNANIMOUSLY

Secretary, Capitol Hill Amateur Softball Association, submitted a letter inviting members of Council to attend the annual Registration Day and Picnic of the Association in Confederation Park at 10:00 a.m. on September 10, 1966.

It was pointed out to Council that its members will be touring the Municipal Golf Course at the time of the picnic and registration of the Capitol Hill Amateur Softball Association.

It was understood that Councillor Hicks would attend the event planned by that $\mbox{\sc Association.}$

<u>City Clerk, City of Vancouver</u>, submitted a letter advising that the City has been asked to submit an invitation to the Canadian Amateur Sports Federation to hold the first Summer Games in the City in either July or August of 1969.

He requested that Burnaby support the City in advancing a submission to the Federation.

The City Clerk also asked that Burnaby send the City an inventory of the Sports facilities in the Municipality.

MOVED BY COUNCILLOR DRUMMIOND, SECONDED BY COUNCILLOR McLEAN:
"That the submission which the City of Vancouver will be making to the
Canadian Amateur Sports Federation be supported in principle and the
Parks and Recreation Commission be requested to supply the City with the
information concerning the Sports facilities in Burnaby."

MOVED BY COUNCILLOR HICKS, SECONDED BY COUNCILLOR DAILLY: "That the Council now resolve itself into a Committee of the Whole."

It was directed that the matter be brought forward to Council at its next meeting and that a full explanation be provided then in regard to the proposal described by Councillor McLean.

(17) Pollution of Burrard Inlet Waters

During discussion, it was pointed out that the Greater Vancouver Sewerage and Drainage District has undertaken a number of major projects during recent years designed to eliminate the discharge of sewage into natural bodies of water by transporting this effluent to sewage treatment plants. It was mentioned that examples of the facilities provided by the District are the Highbury Tunnel, the Marine Drive Interceptor, the Iona Island Treatment Plant and the Lions Gate Treatment Plant.

A statement was made that the Sewerage District will likely be undertaking further projects of this nature in an attempt to totally eliminate the discharge of sewage effluent into natural bodies of water.

The view was expressed that it is expected the incidence of pollution of these waters will be minimized to the point where the effect on the waters will be negligible.

MOVED BY COUNCILLOR DRUMMOND, SECONDED BY COUNCILLOR HICKS: "That the report of the Manager be received and its contents, including the above remarks, be conveyed to the Lochdale (1966) Ratepayers' Association."

A suggestion was made that each member of Council should be supplied with the maps accompanying the Rawn Report so that they may be aware of the existing sewer facilities which have been provided by the Greater Vancouver Sewerage and Drainage District plus future ones.

His Worship, Reeve Emmott, submitted a report advising that it has been brought to his attention that the appointment of Mr. C. 1. Taylor to the Library Doard was in contravention of Section 29 of the Public Libraries Act inasmuch as Mr. Taylor is not a resident of the Municipality nor a property owner therein.

His Worship recommended, in view of this situation, the vacancy on the Board be filled by Mr. N. E. Nelson, 4450 Durke Street, Durnaby 1, D.C.

He added that Mr. Nelson is a teacher in Durnaby and is greatly interested in library service.

MOVED BY COUNCILLOR HERD, SECONDED BY COUNCILLOR HICKS: "That the recommendation of the Reeve be adopted."

His Worship, Reeve Emmott, stated that the Department of Athletics of the Simon Fraser University had approached him to ask Council to place an advertisement in the Souvenir Programme which is published in connection with a Football Game that is played between the "Clansmen" of S.F.U. and another team.

MOVED BY COUNCILLOR McLEAN, SECONDED BY COUNCILLOR HICKS:
"That Council not insert an advertisement in the Programme mentioned
by His Worship because it feels publicity related to sports programmes
does not fall within the policy of Council."

COUNCILLOR DAILLY stated that there is land on David Drive from which a portion is required for road widening purposes.

He suggested that the time was opportune for the Municipality to obtain this land because the property was in the hands of an estate.

Councillor Dailly also remarked that residents in the area have indicated they are prepared to obtain the necessary land for the widening of David Drive but they were concerned as to whether they or the Municipality would pay for the cost of actually constructing the road widening.

It was mentioned that there are portions of other various streets in the Municipality which are narrower than the rest of the particular street because land has not been dedicated for road purposes.

A contention was made that the Municipality should endeavour to acquire these lands so as to provide a road of uniform width.

While discussing David Drive, a suggestion was made that the fence on this street perhaps required attention or maintenance.

"That an investigation be made to determine the possibility of obtaining land from the various properties alluded to above for road widening purposes and, further, that the suggestion concerning the fence on David Drive be investigated."
