Gentlemen:

Your Manager reports as follows:

1. Re: Subdivision Reference #192/66

A proposed subdivision of a portion of D.L. 135, Group 1, Plan 3072 save and except Plans 3234 and 4484, located on the south side of Kitchener Street, east of Augusta Avenue, (see attached sketch) provides for the northern portion to become a road allowance.

Since November 10th, 1953 there has existed an easement in favour of the Trans Mountain Oil Pipe Line Co. covered by right-of-way Plan Mo. 12638 and involving the north 53' of the property.

The proposed subdivision obviates the necessity for the easement and the Trans Mountain Cil Bipe Line Co. has concurred in the dedication of the resulting right-of-way on condition that it is granted a permit by the Corporation to meintain its pipe line in the same territory. The penalt to this effect has been drawn up and submitted to the Flanning Department.

It is recommended that the permit be granted and that the Reeve and Clerk be authorized to sign the necessary document.

 Re: Tendors for Installation of Omnamental Street Lighting -Geneda May.

Tenders were received for the subject project up to 3:00 p.m. local time, "ednesday, January 31, 1968.

The work to be executed under this contract consists of the complete installation of 53 ornamental street standards, including luminaires, lamps, photo cells and duct work. Materials for installation will be supplied by the Corporation with the exception of the conduit, wiring and concrete bases.

Three tenders were received and opened in the presence of Mr. V. D. Kennedy, Mr. E. E. Olson, Mr. R. J. Constable, Mr. K. F. Williems and representatives of the firms bidding.

A tabulation of the tenders is attached.

It is recommended that the tender of Norburn Electric Ltd. be accepted.

3. Re: Tenders for Construction of Senitary Severs, Cambridgefugueta Area - Spines No. 1 and 3 and Areas No. 1 and 4a.

Teaders were received for the subject project up to 3:00 p.m. local time, Medaesday, January 31, 1969.

- 3. Ra: Tenders for Construction of Sanitary Sewers, Cambridge-Augusta
 Area, etc. --- continued --
 - A. Approximately 7,550 linear feet of scaltary sewers consisting of sizes 8", 10", 12", 15" and 18" diameter sewer mains.
 - B. Approximately 1,250 linear feet of size 18" diameter sanitary sewers on piles.
 - C. Total length of piles, approximately 1,780 vertical feet.
 - . Approximately 48 service connections.

Item 10 was before Council at its meeting on 29th January, 1968. The item was tabled.

Further discussions were held with Mr. Alexander of Union Oil and Mr. Alexander suggested that the Company be given an opportunity to defend its position directly to Council.

Your Municipal Manager agreed and the Municipal Clerk has so advised the Company. It is expected that a representative of the Company will be at the Council meeting on Monday, 5th February, 1968, prepared to speak on behalf of the Company.

5. Re: Miller Avenue - Letter from W. and J. Heckmann.

Burnaby has found it impractical and costly to pursue oiling or chloriding of gravel surfaces during the rainy season as the effect of either product is usually washed away in a matter of hours.

Miller Avenue offers no unusual or peculiar circumstances which would justify special consideration being given to it for paving over many other streets of this nature in the municipality.

6. Fe: Lighting - Penzance Drive and Willington Avenue.

Council asked that this intersection be examined to determine if a street light should be installed.

This intersection has at the present time a B. C. Hydro lease N.V. lamp on the wood pole on the southeast corner. It is considered that this is adequate until such time as an ornemental system can be provided in the area.

7. Re: Final Recest Budget for the year ended 31st December, 1967.

Submitted herewith for the consideration of Council is the Final Recast Budget for the Year 1967 as prepared by the Municipal Treasurer upon the closing of the books of the Corporation for 1967.

This Recast shows a surplus on Operations for the year of \$258,505.00. This amount is divided:

Parks - \$ 55,707. General - 202,798. Total \$ 258,505.

The 1967 Budget provided for a Surplus/Contingency of \$90,000. This was reduced to \$46,766. in the October recast and is \$250,505. in the 1967 Final Recast.

The surplus from 1966 brought forward into the 1967 Budget was \$219,440.

The difference of \$211,739 between the Recast and Final Recast Budget results from decreased expenditures of \$372,493. less decreased revenues of \$160.754.

It is recommended that the Final Recast be adopted and the surpluses of \$55,707, and \$202,798, be brought forward into the respective Budgets for 1968.
