**4. DELEGATIONS**

**4.1 Simon Tooley - Re: Burnaby Mountain Gondola Proposal  
Speaker: Simon Tooley**

Mr. Simon Tooley appeared before Council via Zoom regarding the proposed Burnaby Mountain Gondola project.

Mr. Tooley expressed concern in relation to the safety of residents and school children under the gondola pathway, and the need for a 300 foot swath (fire suppression zone) through the Burnaby Mountain Conservation Area. Mr. Tooley requested that Translink investigate rescheduling transit buses to addresses peak service time requirements, thereby mitigating the need for a gondola.

In conclusion, Mr. Tooley thanked Ms. Katrina Chen, MLA Burnaby-Lougheed, for her proactive involvement.

**4.2 Peter Cech - Re: Through Traffic in Burnaby  
Speaker: Peter Cech**

Mr. Peter Cech appeared before Council via Zoom regarding safety concerns due to commuter traffic in North Burnaby residential neighbourhoods.

The speaker requested that the City address rush hour commuter traffic which is bypassing Hastings Street by re-routing through the Capitol Hill and Heights neighbourhoods. Mr. Cech advised that residents have few options to counter the traffic issues in their neighbourhoods due to the absence of a comprehensive approach and no visible enforcement.

The speaker requested that staff install barriers along Penzance Drive at; North Gamma and North Beta Avenues, in an effort to reduce through traffic in North Burnaby neighbourhoods.

### 5.1 **City of New Westminster - Re: Equity and Diversity on the E-Comm Board**

Correspondence was received from the City of New Westminster outlining the importance of balanced and equitable E-Comm Board representation, and seeking Council support for the nomination of Councillor Nancy McCurrach, City of Port Coquitlam, to the E-Comm Board for the 2021-2022 term.

### 5.2 **Union of BC Municipalities - Re: Benefits of Public Car Insurance (2020 Resolution Referred to UBCM Executive)**

Correspondence was received from the Union of BC Municipalities advising that the City of Burnaby's resolution regarding Benefits of Public Car Insurance was included in the 2020 Resolution Book for consideration at the annual UBCM Convention. However, due to a lack of time at the Convention, delegates did not have an opportunity to consider the resolution, and the resolution was automatically referred to the UBCM Executive for consideration and action. At the 2021 February Executive meeting, the Executive decided to refer the resolution back to Burnaby, with a recommendation to re-submit it for 2021.

The Benefits of Public Car Insurance resolution is as follows:

WHEREAS public car insurance creates local jobs and significant investments in municipalities through road safety and improvement, grants-in-lieu, and community grants while providing greater control to municipalities to plan for risks and costs;

AND WHEREAS jurisdictions with only private insurance options have experienced significant rate hikes year after year while accident benefits dramatically decline;

THEREFORE BE IT RESOLVED that UBCM request the Provincial Government to preserve public car insurance, including jobs and local investments, in British Columbia.
