#### REPORT

#### 1.0 INTRODUCTION

This report is being provided to the Financial Management Committee for information on the 2020 year end status of the Gaming Reserve and the Gaming Interest Reserve in preparation of the annual return to the Province.

#### 3.0 BACKGROUND

Through the Host Financial Assistance Agreement with the Province of BC, the City receives ten percent (10%) of the net Provincial proceeds from the Grand Villa (Gateway Casino). The City uses these funds for Council approved initiatives of a one-time nature. The eligibility criteria for the use of casino gaming grants include operating expenditures and/or capital projects that serve to protect or improve Burnaby's environment, including beautification, heritage, public safety, international relations, arts and culture or other projects or programs at the discretion of Council.

In addition, operating expenditures and/or capital project initiatives would satisfy the following criteria:

- a) Ad hoc pilot projects which extend over a specific period of time.
- b) Discrete capital projects that do not require ongoing capital funding requirements.
- c) Gaming funds on hand shall be sufficient to complete the proposed project.
- d) The activity and/or project shall have little or no ongoing impact on the operating budget or result in a reliance on the property tax levy.

Council reviews and approves all operating expenditures and capital project initiatives funded by the Gaming Reserve annually prior to inclusion in the Financial Plan.

Attachment 1 (Gaming Reserve Summary by Year 2000 – 2020) provides a summary of the Gaming Reserve grants received and the expenditures made for the entire period of this Provincially funded program. Furthermore, a 2021 forecast based on operating initiatives and capital projects approved to utilize the Gaming Reserve, which is included in the 2021 – 2025 Financial Plan, has also been included on Attachment 1 for information purposes. As per the Host Financial Assistance Agreement, all grants received and expenditures made are to be reported back to the Province on a cash basis. This information will be reported to the Province by 2021 April 24.

Expenditures funded from the Gaming Reserve for 2020 totaled \$11,703,901, of which \$917,017 were operating expenditures and \$10,786,884 were capital expenditures. Attachment 2 provides the details of these expenditures. In 2020, the City budgeted to receive approximately \$11,500,000 in gaming grants from the Province. However, due to the closure of the Grand Villa Casino in response to the COVID-19 pandemic in 2020 March, the casino grants received in 2020 from the Province totaled \$5,342,091; \$3,159,708 for Q4 of 2019 and \$2,182,383 for Q1 of 2020. The balance of the Gaming Reserve at the end of 2020 was \$77,523,300.

The following table provides the actual gaming grants received by the City for the past 5 years (2016 to 2020) compared to budget:

Due to the uncertainty of the Grand Villa Casino re-opening, the 2021 gaming grant budget has been reduced to \$3,250,000 in the 2021 – 2025 Financial Plan in anticipation that the casino will open for a quarter of the year in 2021.

At the end of each fiscal year, the total annual interest income earned on the balance of the Gaming Reserve is transferred to the Gaming Interest Reserve with the intent to use the proceeds to fund priority one-time operating projects as determined by Council.

Interest earnings on the Gaming Reserve totaled \$2,679,269 in 2020. Operating expenditures funded by the Gaming Interest Reserve in 2020 amounted to \$806,360, leaving an ending balance of \$10,692,977. Attachment 3 provides details of these expenditures.

The Gaming Reserve and the Gaming Interest Reserve have sufficient funding available for capital and operating initiatives outlined in the 2021 – 2025 Financial Plan. These funding sources continue to allow the City to provide for programs and resources that would otherwise have to be funded from taxation increases.

#### 4.0 RECOMMENDATION

It is requested that the Financial Management Committee recommend Council receive this report for information.
