FUNDING REQUEST

PURPOSE: To request the use of Waterworks Utility and Sanitary Sewer Fund Reserves

and to request a Capital Reserve Fund Bylaw to finance 2021 - 2023

Engineering capital infrastructure projects.

RECOMMENDATION:

1. THAT the Financial Management Committee recommend Council authorize the City Solicitor to bring forward a Capital Reserve Fund Bylaw in the amount of \$6,623,000, the use of the Sanitary Sewer Fund Capital Reserve in the amount of \$150,000 and the use of the Waterworks Utility Capital Reserve in the amount of \$150,000 to finance Engineering capital infrastructure improvement projects, as outlined in this report.

REPORT

INTRODUCTION

The 2021 – 2025 Financial Plan provides funding for various multi-year capital improvement projects. In order to proceed with design and construction, funding approval is requested for the projects listed below.

1.0 Infrastructure

1.1 Sidewalks and Full Road Upgrades

Estimated \$6,623,000

This project started design in 2020 for streets identified as part of the overall sidewalk expansion program that staff also identified as requiring full road upgrades. Due to this additional scope, design efforts will include utilities, curb and gutter, streetlights, curb bulges, IT conduit, and road paving on top of sidewalk installation.

On 2019 June 24, Council instructed staff to accelerate net new sidewalk construction at a value of \$10 Million per year. Boulevard trees would also be replaced and added as necessary, in order to complete the public realm.

The scope of work involves 2021 construction of sidewalks and road upgrades at 11 locations, with some streets requiring curb bulges, street lighting and IT conduit installation.

Included in Appendix A is a detailed list of proposed locations.

1.2 Water and Sewer Pump Station Upgrades

Estimated \$300,000

This project is to upgrade and standardize the City's Supervisory Control and Data Acquisition (SCADA) system for water, sanitary, and drainage assets that require SCADA. This project also includes new radio equipment to use the licensed radio channels which requires coordination effort between Engineering and IT.

Funding of \$100,000 was raised during the January 2021 FMC meeting to begin preliminary work and assessment. An additional \$300,000 is being requested in order to award the contract for completing the North SCADA stations for programming and commissioning, establishing new access points at Metro Tower 1 and Burnaby Mountain.
