PURPOSE: To provide Executive Committee and Council with information on changes

to the 2022 Living Wage Rate - Metro Vancouver.

REPORT

1.0 INTRODUCTION

In accordance with the annual review of Living Wage for Families BC, the City of Burnaby will adopt the increase in the 2022 Living Wage rate for those Burnaby employees impacted by this change.

This report provides an overview of the changes to Metro Vancouver's Living Wage rate for 2022.

2.0 BACKGROUND

On 2019 June 25, City Council approved a motion committing the City of Burnaby to implement a Living Wage Program and seek Living Wage Employer certification. Effective 2019 October 1, the City implemented the Living Wage for BC - Metro Vancouver of \$19.50. The Living Wage rate is reviewed annually by Living Wage for Families BC. In 2020, due to the impacts of the COVID-19 pandemic, the Living Wage rate was maintained at the 2019 level. In 2021 November, Living Wage for Families BC announced the 2021 living wage rate of \$21.52 (increase of 10.4%).

3.0 2022 LIVING WAGE RATE

In 2022 November, Living Wage for Families BC announced that the Living Wage rate would increase by 11.9% to \$24.08. This equates to a \$2.56 increase, from \$21.52 to \$24.08. The 11.9% Living Wage increase is largely due to the rising costs of food and housing in BC, the two biggest essentials in a family budget. The increase in the Living Wage rate will be paid retroactively from 2022 November 21, for those Burnaby employees impacted by this change. A summary of the number of employees impacted and the total cost of the Living wage adjustment by year, is shown in table 1 below:
