REPORT

1.0 INTRODUCTION

A request to use City streets for Hats Off Day Festival on Saturday, 2022 June 18 between 9:30 am – 4:30 pm has been received from Mischa Greenwood – Chair, Hats Off Day Committee.

2.0 POLICY SECTION

3.0 BACKGROUND

This year's Hats Off Day Festival is proposed to take place on Saturday, 2022 June 18; however, there will be no parade planned as part of the program. The organizers are seeking similar assistance from the City of Burnaby as they have received previously, including support for the necessary street closures, parking restrictions, traffic control, sanitation services, and utilization of the Heights Fountain Square and Urban Renewal Site adjacent to Hastings Street.

Hastings Street between Boundary Road and Gamma Avenue will be closed between 9:30 am and 4:30 pm on 2022 June 18. At the same time, adjacent cross streets and laneways along Hastings Street will be closed between Albert Street and Pender Street. Hastings Street will be closed for vehicle access with pedestrian oriented activities, including Show & Shine Car Show and Family Fun Dash.

The organizers are aware that approval is subject to the following conditions:

- 1. That the festival be conducted under the supervision of a designated marshal or event organizer.
- 2. That all participants be instructed to respect the rights and property of the individuals encountered en route.
- 3. That the RCMP has agreed to control and monitor traffic operations at Hastings Street and Willingdon Avenue for the duration of the road closure.
- 4. That the organizers are responsible for arranging for barricade volunteers for all barricade locations except where RCMP will be present.
- 5. That all emergency and transit services are advised of the event.

- 6. That the organizers send out letters to residents that are affected by the road closures and temporary parking restrictions two weeks prior to the event.
- 7. That the festival be covered with liability insurance in the minimum amount of \$5 million with the City of Burnaby named as co-insured, and that the insurance policy include a 30 day cancellation notice and a cross liability clause.
- 8. That a signed copy of the "City of Burnaby Permit For Short Term Use and Occupancy Of City Lands" be received no later than one week prior to the event.

As in past years for previous Hats Off Day Festivals, City staff will be providing the requested support and the RCMP will ensure that a safe environment exists by having staff members available.

4.0 **RECOMMENDATION**

Staff recommend Council's approval of the road closures for Hats Off Day as outlined in this report.
