An application was received from Burnaby and Region Allotment Gardens Association for an operating grant to offset costs for salary for a summer groundskeeper. The organization is made up of 400 members that actively grow organic fruit and vegetables in a 14 acre allotment garden on City of Burnaby leased land. The fresh produce is donated to local foodbanks such as the Burnaby Neighbourhood House. The position for a groundskeeper will run full-time from May to September and is essential to operations.
