**PURPOSE:** To obtain Council approval to award a contract for the Capital Projects

Delivery Services.

## **RECOMMENDATION:**

1. THAT Council approve a contract award to Colliers Project Leaders Inc., for a total cost of \$4,548,625.00 including GST in the amount of \$216,601.19 as outlined in this report. Final payment will be based on the actual quantity of services delivered and hourly rates as submitted.

## **REPORT**

Eight submissions following a Request for Proposal were received by the closing time on 2022 July 07. The scope of work of this contract includes professional services to support City's Lands and Facilities and Engineering departments, such as, act on behalf of the City as the City's representatives to help with planning, management and delivery of capital infrastructure, and civic facility projects within their intended scope, schedule, and budget as stipulated in the capital plan.

Review by City staff indicates the consultant has the necessary personnel to successfully complete the work required under this contract. The General Manager Lands and Facilities and Acting General Manager Engineering concur with the above recommendation.

Funding for this capital work is included in the 2022 – 2026 Financial Plan for various capital projects under Lands and Facilities (\$3,522,500) and Engineering (\$809,500).
