SUBJECT: UPDATED IMPLEMENTATION DATE FOR SOME 2023 PARKS.

PURPOSE: To obtain Council's approval for updated implementation date for some

2023 Parks, Recreation and Culture fees and charges.

RECOMMENDATION:

1. THAT Council authorize the City Solicitor to bring forward a bylaw to amend the Burnaby Parks, Recreation and Culture Fees Bylaw 2023 to update the implementation date for fees and charges identified in the report titled "Updated Implementation Date for Some 2023 Parks, Recreation and Culture Fees and Charges" from the General Manager Parks, Recreation and Culture.

REPORT

1.0 POLICY SECTION

The request outlined in the report supports the Burnaby Strategic Plan: providing positive customer experiences; and the Burnaby Promise: putting the needs of the community first.

2.0 BACKGROUND

The Parks, Recreation and Culture Fees Bylaw 2023 was adopted by Council on March 27, 2023. At the time, the effective fee dates were aligned with the "Go-Live" date of the new ActiveNet software in November 2023. In early March 2023, Spring program registration occurred and many measures were taken to improve the customer experience. It was realized that the transition to the new ActiveNet registration system needed to be prioritized and made available to the public as soon as possible. As a result the ActiveNet "Go-Live" date has been advanced from November to July 2023.

3.0 DISCUSSION

In order to provide a smooth transition between software systems, the dates of the 2023 Facility Use Bylaw Fees require some adjustments to align with a July "Go-Live" date. It is most efficient to roll out all admission and membership fees on July 18 to provide a seamless transition for both patrons and staff.

Staff are requesting Council's approval to amend the below noted fees and charges with the updated implementation date of July 18, 2023:

With the *Be Active* Admission & Pass fees aligning with the ActiveNet "Go-Live" date, the need for a *Super Pass* is no longer required. The purpose of this pass was to provide a bridge between the implementation of fees and the new software. Staff are requesting Council's approval to remove the *Super Pass* from the fees and charges schedule in the Parks, Recreation and Culture Fees Bylaw 2023.

There will be no other changes to the Parks, Recreation and Culture Fees Bylaw 2023. The implementation dates for other fees and charges will remain the same as Fall will be the first season using ActiveNet for program registration and facility reservations.

4.0 BYLAW AMENDMENTS

In order to implement the changes outlined in this report, the following amendments to the Parks, Recreation and Culture Fees Bylaw 2023 are proposed:

Section 2 – repeal and replace with the following:

2. The City of Burnaby imposes facility rental, admission and equipment fees for Parks, Recreation and Culture facilities and equipment in accordance with Schedule "A" of this bylaw, effective 01 September 2023, with the exception of:
