CA – MAJOR TRAFFIC MANAGEMENT PROJECTS – PACKAGE II SUBJECT: PURPOSE:

To obtain Council approval for a Contract Award (CA) with Jack Cewe

Construction Ltd.

RECOMMENDATION

THAT a contract award to Jack Cewe Construction Ltd., for an estimated total cost of \$9,564,019 including GST in the amount of \$455,429, as outlined in the July 10, 2023 Council Report titled "CA – Major Traffic Management Projects – Package II" be approved; and

THAT final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.

CHIEF ADMINISTRATIVE OFFICER'S COMMENTS

I concur with the recommendation of the Deputy Chief Administrative Officer and Chief Financial Officer.

1.0 **POLICY SECTION**

The City's Procurement Policy requires that award of contracts for goods, services and construction with values over \$1,000,000 be approved by Council following a competitive procurement process.

2.0 BACKGROUND

Five tenders ranging from \$9,564,019 to \$12,668,880 were received by the closing time of June 19, 2023.

The lowest tenderer, Jack Cewe Construction Ltd. has completed previous projects under contract to the satisfaction of the City. The contractor's pricing is competitive and reflective of the current market conditions. Our consultant's review indicates the contractor has the equipment and personnel capability to successfully complete the work required under this contract. The General Manager Engineering concurs with this recommendation.

3.0 GENERAL INFORMATION

The scope of this project includes new traffic signals, pedestrian signals, Rectangular Rapid Flashing Beacon (RRFB)'s installation, intersection realignment, new intersection turning lanes, street upgrades with new curb/gutter, curb extensions, wheelchair letdowns, new sidewalks, existing sidewalks upgrades, bus landing pads, and/or new Multi Use Pathways (MUP) at the following locations:

Sperling Corridor:

- Sperling Avenue and Union Street;
- Sperling Avenue and Curtis;
- Sperling Avenue and Kitchener Street;
- Sperling Avenue and Halifax Street;
- Sperling Avenue and Adair Street;
- Sperling Avenue and Hycrest Drive; and
- Sperling Avenue and Broadway.

Duthie Corridor:

- Duthie Avenue and Pandora Street:
- Duthie Avenue and Union Street;
- Duthie Avenue and Curtis Street:
- Duthie Avenue and Greystone Drive; and
- Duthie Avenue and Kitchener Street.

Other Locations:

- Royal Oak Avenue and Victory Street:
- Royal Oak Avenue and Watling Street;
- Hycrest Drive Sperling Avenue to Adair Street;
- · Adair Street Sperling Avenue to Hycrest Drive; and
- Kitchener Street Duthie Avenue to Augusta Avenue.

4.0 COMMUNICATION AND COMMUNITY ENGAGEMENT

The Tender #118-04-23 (CA-3212) Major Traffic Management Projects – Package II (Attachment 1) was publicly advertised. Upon closing, the City received a total of five submissions.

5.0 FINANCIAL CONSIDERATIONS

Funding for this capital work is included in the 2023 – 2027 Financial Plan under Engineering – Transportation for Major Traffic Management Projects under WBS EMF.3212 (\$9,108,600). To accommodate this contract award the Traffic/Transportation capital program has been reprioritized to reallocate \$7,400,000 from various projects.
