5. DELEGATIONS AND INVITED PRESENTATIONS

5.1 Invited Presentation: Local Hero Awards Recognition <u>Presenters:</u> Mayor Hurley and Councillor Dhaliwal, Chair, Executive Committee of Council

Mayor Hurley introduced Local Hero Awards Program and recognized this year's Local Heroes. The following were the Mayor's remarks:

"Local Heroes are people who have made outstanding contributions to our community's well-being. I am pleased to have the opportunity tonight to recognize seven (7) individuals for their significant accomplishments and the positive impacts they have made on the City and citizens of Burnaby.

2024 marks the 26th year the City has recognized its Local Heroes. The total number of Local Heroes in Burnaby, including the people being recognized this evening, now stands at 292. Local Heroes represent an impressive cross-section of Burnaby citizens.

At this time, I would like to thank our schools, libraries, recreation centres and community agencies for helping to spread the word about the program. I'd also like to extend a special thank you to the people who took the time and initiative to put together nomination submissions this year. Without the efforts of the nominators, the Local Heroes Award program would not be the success that it is today.

Each of the Local Heroes will receive a Certificate of Recognition. I would ask now Councillor Dhaliwal to provide you with some background information on City of Burnaby's 2024 Local Heroes.

LOCAL HEROES

Sharon Domaas (Sharon Domaas' daughter Kristina accepted award on her behalf)

For the past 12 years, Sharon Domaas has volunteered as one of the key members of the Burnaby Association for the South East Side (BASES) which is a foundation dedicated to building strong foundations for children, youth and families through the work of BASES Family Thrift Store. Sharon was the first President of BASES leading the organization formation, purpose, and visioning. Sharon has volunteered in the operations of the store as well as serving on the Administrative and Human Resources Committee. Sharon contributed wherever there was a need. In addition, since 2002, Sharon has volunteered at Edmonds Community School conducting the Roots of Empathy program in a Grade 1 class, which brings a young infant and mom into a classroom monthly with the purpose of building caring and developing empathy in children.

Jane Leah

Jane has been volunteering at Citizen Support Services since 2005 where she has dedicated approximately 1,100 hours of her time to seniors in the City of Burnaby. During the 19 years, Jane has volunteered as a Volunteer Visitor to isolated seniors, a Volunteer Driver to ensure seniors can partake in our events, and most importantly the team lead for the Shopping Buddies program once a week at Metrotown Mall. Jane's punctuality, attention to detail, caring and wonderful personality endear her to all her clients.

Laurie Molstad

Laurie is a dedicated volunteer in Burnaby who is committed to the well-being of children. Laurie has been actively involved in Burnaby Association for the South East Side (BASES) since its inception 11 years ago. BASES is a non-profit organization that assists children and youth attending elementary and secondary schools in Burnaby through the funding of after school programs. To accomplish this goal, BASES operates BASES Family Thrift Store and uses the proceeds to fund initiatives. To date, BASES has donated more than \$750,000 to Burnaby schools and has had a huge impact on thousands of students. Laurie has helped to make that happen. In addition, Laurie volunteered as an instructor with the Roots of Empathy program. Through the lessons, Laurie provided, children at Stoney Creek Community School connected with a baby who visited their classroom throughout the year.

Ryan Males

Ryan Males has been a volunteer with Burnaby Community Services (BCS) since 2015. Through his own initiative, Ryan approached BCS to act as the community hub to benefit from community donations and assist with the distribution of food. What started as 245 family packages in 2015 has become more than 600 packages for 2023. In addition, the efforts of Ryan each holiday season to mobilize neighbours and the business community assists organizations like Margaret's Housing for Older Women, Progressive Housing Society and The Society to End Homelessness in Burnaby provide support of some of the most vulnerable people in Burnaby with basic life necessities, social aid and resources to provide independence.

Samantha Nelson

Samantha Nelson has been volunteering in Burnaby since 2016 for various organizations. Samantha volunteers within her community by distributing food and goods to families in need with The Society to End Homelessness in Burnaby. Samantha also helps organize the Coldest Night of the Year event for the Society to End Homelessness in Burnaby, encouraging people to sign up, setting up the routes and organizing donations. In addition, Samantha volunteers with Edmonds Housing Coop, planning events on all occasions for the community children as a member of the Social Committee.

Josie Polisi

Josie has been volunteering at Citizen Support Services since January 2001 where she has dedicated approximately 1,300 hours of her time to seniors in the City of Burnaby. During the 23 years Josie has served as a Volunteer Assistant spending time socializing with isolated seniors when attending special events in the city. In addition, Josie is a Volunteer Driver for seniors and Josie volunteers once a week as a Shopping Buddies assistant. Josie is warm and articulate and extremely helpful to the senior clients.

Polly Voon

Polly Voon has been a volunteer with Lions Club International for over 35 years. In this time Polly has been in leadership roles, providing mentorship and leadership training to members on both local and international levels, ensuring an active role in her hometown of Burnaby. Trained members support service work in the Burnaby community assisting many organizations. Polly is also involved with the Lions Club Dog Guides program and has been an active volunteer since July 1998. In addition, Polly serves as a volunteer on the Malaysia Singapore Brunei Cultural Association where she helps organize events such as cultural dances, community picnics and supporting individuals in need."

Mayor and Council members congratulated the Local Heroes and provided each with a Certificate of Recognition.

5.2 Invited Presentation: BC Housing and Fraser Health - Re: Complex Care Housing Information <u>Presenters:</u> Naomi Brunemeyer, Director of Regional Development, BC Housing, and Becky Doherty, Clinical Director, Mental Health & Substance Use, Fraser Health

Naomi Brunemeyer, Director of Regional Development Sea to Sky, Sunshine and North Coast, Metro Vancouver and Fraser Valley, BC Housing, and Becky Doherty, MSW, RSW, Clinical Director, Mental Health & Substance Use, Fraser Health, appeared before Council providing information on Complex Care Housing and advising that the City of Burnaby, one of the community in the Lower Mainland, will receive a funding from the Ministry of Mental Health and Addictions for 10 Complex Care Units.

*Councillor Lee left at 5:17 p.m.

Naomi Brunemeyer noted that Complex Care program was announced in 2023, and additional 240 Complex Care Housing units will be provided in BC (Abbotsford, Burnaby, New Westminster and Surrey). BC Housing will deliver capital program, acquire land, hold lease, build project out, and provide access to operating funding for property management. Large amount of funding will be provided by the Fraser Health Authority for clinical base staff that will be required.

Becky Doherty advised that the Complex Care Housing is intended to support adults who have significant health issues, including mental health and substance use challenges; offers voluntary, enhanced levels of integrated health, social and cultural support to people where they live; and it is partnership between health services and the housing provider. *Councillor Lee returned at 5:19 p.m.

The speaker noted that the goal is to improve connection to health services and improve health outcomes; reduce acute site visits and emergency services contacts; support coordinated, effective and culturally safe housing and health services; and support people to maintain their housing and improve their quality of life.

The delegation advised that Complex Care is close working partnership between housing and health care; staff are trained in cultural safety and concurrent disorders; services are co-located on site, and this helps foster relationships between service providers and residents.

Naomi Brunemeyer outlined the next steps:

- model refinement based on Burnaby's needs and potential to co-locate with additional housing;
- site identification and due diligence;
- public RFP for operator;
- advance design in collaboration with City, FH, MMHA and Operator and
- public engagement and municipal process confirmation.

Council members noted the program's merits and need, as well as indicated alignment with the recommendations coming from the Mayor's Task Force for Unsheltered Community Members. Council members indicated they look forward to working with the delegates on the implementation of the Complex Care units in Burnaby.

Staff will report back to Council at a future date on options for the program.

*Councillor Keithley arrived at 5:30 p.m.

WHEREAS funding for care must be spent on care. If additional revenue is needed to fund other operational costs, it should not be procured from funds meant for direct care; and

AND THEREFORE BE IT FURTHER RESOLVED THAT the Provincial Government create a standardized funding formula and reporting system to ensure that funding for care, is spent on direct care only and enact legislation that requires public funding for direct care staffing to be spent on direct care only.
