A By-law to enable the Corporation of the District of

Burnaby to raise by way of Loan the sum of \$586600.00

for Street Purposes.

WHEREAS it is necessary and expedient that the Council of the said Corporation be authorised to borrow the sum of \$500000.00 to provide for improving certain roads within the limits of the Municipality.

AND WHEREAS an approximate estimate of the amount required for the various roads has been made by the Council as follows:

AND WHEREAS it is necessary to raise the moneys required to defray the above expenditure upon the credit of the Municipality.

AND WHEREAS it will be necessary to raise annually by special rate the sum of Five thousand two hundred and sixty two (\$5,262.00) Dollars principal and the sum of Twenty-two thousand five hundred (\$22,500.) Dollars interest making together a total amount annually of Twenty-seven thousand seven hundred and sixty-two (\$27,762.) Dollars for the term of forty (40) years for the repayment of the said loan and interest thereon as hereinafter mentioned.

AND WHEREAS the net value of the whole rateable land in the Municipality according to the last revised assessment roll amounts to Ten million four hundred and eighty-six thousand eight hundred and ninety-five (\$10,486,895.00) Dollars.

AND WHEREAS the total existing Debenture's debt of the Municipality is Two hundred and eighty-four thousand (\$284,000.00) exclusive of local improvement, secured by special rates or assessments of which none of the principal or interest is in arrears.

AND WHEREAS to provide for the payment of interest and the creation of a sinking fund for the payment of the said principal sum of \$500000.00 it will be necessary to levy a special annual rate sufficient to raise the sum of Twenty-seven thousand seven hundred and sixty-two (\$27,762.00) Dollars the amount to be calculated annually on the whole of the rateable land comprised within the Municipality.

BE IT THEREFORE ENACTED by the Reeve and Council of the said Corporation of the District of Burnaby in open Council assembled as follows:-

l. It shall be lawful for the Reeve and Clerk of the Council for the purposes aforesaid to borrow or raise by way

of loan from any person or body or bodies corporate who may be willing to advance the same upon the credit of the debentures hereinafter mentioned a sum not exceeding \$500,000.00 and to cause the same to be placed in the Royal Bank of Canada at the City of New Westminster, British Columbia to the credit of the said Corporation for the purposes and with the objects above set forth and to issue any number of debentures of the said Corporation to the sum of \$500,000.00 in the whole in accordance with the "Municipal Clauses Act" in sums as may be required not less than \$500.00 each or an equivalent expressed in Pounds Sterling of the United Kingdom of Great Britain and Ireland, at a value of \$4.86 2/3 to the Pound Sterling, said debentures to be sealed with the corpor te seal and to be signed by the Reeve and Clerk.

- exceeding four and one-half (4½) per centum per annum payable half-yearly on the Thirtieth day of fine and the Thirty-field day of Jeelmber respectively in each and every year during the currency of the said debentures or any of them.
- shall be payable at any Branch of the Royal Bank of Canada in Canada, or their Agents in the City of London, England and as to principal the debentures shall be made payable at the end of forty (40) years at the farthest from the day hereinafter mentioned for this by-law to take effect and shall have coupons attached to them for the payment of interest.
- 4. There shall be raised and levied annually by a special rate sufficient therefor on all rateable land within the limits of the said Municipality the sum of Five thousand two hundred and sixty-two (\$5,262.00) Dollars for the purpose of forming a sinking fund for the payment of the said debentures and the sum of Twenty-two thousand five hundred (\$22,500.) Dollars for the payment of the interest at the rate

aforesaid to become due on such debentures during the currency thereof, the said special rate to be in addition to all other rates to be levied and collected in the said Municipality during the currency of the said debentures or any of them.

- 5. This by-law shall take effect on and after the 17th day of April, 1911.
- 6. This by-law may be cited for all purposes as "BURNABY ROAD IMPROVEMENT DEBENTURE BY-LAW 1911"

DONE AND PASSED by the Council in open Meeting on the third day of April 1911.

RECEIVED the assent of the Electors at an election for the purpose on the 15th day of April RECONSIDERED and finally adopted by the Council, Digned by the Reeve and Clerk and Sealed with the Corporate Seal all on the 15th day of April 1911.

- I. William Griffiths, of the District of Burnaby in the Province of British Columbia, Clerk of the Municipal Council of the said District de selemnly declare and say:
- That the By-law known as "Burnaby Road Improvement 1. Debenture By-law, 1911", Number 101 , being a By-law of the said Municipality intituled "A By-law to enable the Corporation of the District of Burnaby to raise by way of loan the sum of \$500,000.00 for Street Purposes", was passed by the Municipal Council of the said District on the Third day of April, 1911. and the Municipal Council of the said District thereupon fixed the Fifteenth day of April, 1911 as the day on which the said By-law would be submitted to a vote for the assent of the Electors thereon and caused a copy of the said By-law with a Notice appended thereto to be published in a Newspaper called the "Daily News" circulating within the said District in the issuesthereof of April 5th, 1911 to April 15th, 1911, (both dates inclusive) a copy of which advertisement is hereto annoxed, Marked "A"
- 2. That a copy of the said By-law with such Notice appended was put up in at least one public place in each Ward of the said District, on or about the Fifth day of April, 1911.
- 3. That the said By-law was adopted by the duly qualified Electors at a Poll duly held on the Pifteenth day of April, A.D., 1911 and the number of persons who voted on the said By-law was 367 of whom 322 voted in favor of the said By-law and 45 voted against it.
- 4. That the said By-law was re-considered, adopted and finally passed by the Municipal Council of the said District on the Fifteenth day of April A.D. 1911, and the paper hereto annowed, marked "B" and certified by me, is a true Copy of the said By-law was thereupon signed by the Reeve and Clerk of the said By-law was

and the Corporate Seal thereto affixed.

- 5. That the said By-law was registered in the office of the County Court of the District in which the District of Burnaby is situate on the Twenty-fifth day of April, 1911.
- 6. That to the best of my knowledge, information and belief no application has been made to quash the said By-law or any part thereof, and no application has been made for a scrutiny of the number of votes pelled for and against the said By-law and no such scrutiny has been held and that the said By-law is in full force and as binding and subsisting as when finally passed, except as amended by By-law No. 101A a copy of which is hereto annexed, marked "C".
- The assessed value of the lands and improvements or real property of the District of Burnaby according to the last Revised Assessment Roll, being for the year 1910, is \$10,486,895.00 and the whole amount of the debenture debt of the said District, exclusive of local improvement, secured by special rates or assessments, but including the amount authorised under the said by-law No. 101 for Street Purposes and By-law No. 100 for waterworks Purposes is \$1,218,500.00.
