A BY-LAW TO FIX THE AMOUNT OF LIQUOR LICENSE FEES IN THE
MUNICIPALITY OF BURNABY AND FOR REGULATING MATTERS CONNECTED
WITH LICENSING AND PROVIDING PROCEDURE UPON COMPLAINTS / GAINST
LICENSE HOLDERS

THE MUNICIPAL COUNCIL of the CORPORATION OF THE DISTRICT OF BURNABY WHISTS as follows:-

- of spirituous or fermented liquors by retail for each house or place where liquor is sold shall be one hundred dollars (\$100.00) for every six (6) months payable in advance.
- spirituous or fermented liquors by retail shall apply, at the meeting of the Board of License Commissioners held next immediately preceding the expiration of such license, for a renewal of such license for six (6) months from the date of its expiration.
- 5. Applications for renewal of licences as provided for in paragraph 2 hereof shall be made semi-annually otherwise such licences shall lague.
- least days prior to the sittings of the Board of Licence Commissioners at which such application is to be made, advertise in some newspaper circulating in the Municipality a notice of intention to apply for renewal in the form following, that is to say:-

Board of Licence Commissioners of Burnaby Municipality for renewal of the licence to sell liquor by retail in the premises known as the Hotel situate at

The applicant shall forward a copy of the said notice to the secretary of the Board at least forward days prior to the meeting of the Board and shall also forward an Inspector's fee of five (35.00) dollars.

- of Licence Commissioners a protest against the renewal of any licence. The grounds upon which the protest is made must be specifically stated in the protest. At least three (3) days' notice of any such protest shall be given to the mecretary of the Board and also to the a plicant.
- any evidence which may be adduced by the person or persons objecting to the application and shall also hear any evidence which may be adduced in reply or explanation by the applicant and shall determine whether the said renewal should be granted or refused. In the event of the Board deciding that it is not expedient to grant a renewal all rights of the applicant under his licence shall above and allow absolutely upon the expiration of the term of his licence.
- 7. The Board of Lic nee Commissioners shall from time to time appoint an Inspector of Licences who shall be Secretary and Inspector for the Board and such officer shall hold office at

the pleasure of the Board.

- 8. All complaints against licence holders shall be made in writing to the Inspector of the Board and the Board may if they consider that it is advisable to investigate any such complaints notify the licence holder to appear before them and show cause why his licence should not be cancelled or suspended in accordance with the powers conferred upon the Board under and by virtue of the Municipal Clauses Act and smending Acts and upon the hearing of any such complaint the Board shall have power to revoke or suspend the licence of such licence holder for any period in the discretion of the Board. The Board may sit ax as often as occasion may require.
- 9. At least three (3) days' notice shall be given to the licence holder of the hearing of any complaint as provided for in the last preceding paragraph hereof and such licence holder shall be at liberty to appear before the Board in answer to such complaint and to adduce such evidence as he may consider advisable.
- 10. The hearing of all applications for renewal of licences and all complaints against licence holders shall be open to the public and shall be conducted in such manner as the Board shall consider expedient.
- 11. This By-law may be cited as the "BURNABY LIGUR DICENCE BY-LAW 1911".
