BY-LAW NO. 162.

A BY-LAW TO AMEND THE "BURNABY TRADES LICENSE BY-LAW 1911".

The Municipal Council of the Corporation of the District of Burnaby enacts as follows:-

1. The said "Burnaby Trades License By-law 1911" is hereby amended by adding at the end of Section 7 thereof the following:-

"(7a.) Any person following the occupation of a travel-"ling Junk Dealer and using a vehicle for the purpose of "his business shall have his name and address printed on "the left hand side of said vehicle in letters not less "than two inches in length."

2. Section 5 of Schedule A of the said By-law is hereby repealed and the following substituted therefor:-

"From any hawker or peddler not being a resident of "the Municipality the sum of \$10.00 for every six months, "and from any hawker or peddler resident in the Munici-"pality the sum of \$5.00 for every six months. Provided "however that this section shall not apply to farmers or "market gardeners selling or offering for sale from house "to house or otherwise the products of their farms or "gardens for which no license fee shall be charged nor to "any wholesale or retail milk vendor not to any licensed "fisherman selling or offering for sale fish which have "been caught with a net and boat owned by him."

3. Section 24 of the said Schedule A is hereby amended by striking out the words and figures "\$5.00 for every six months" in the fourth line thereof and substituting therefor the words and figures "\$10.00 for every six months."

5. Said Schedule A is hereby further amended by adding thereto

"(31.) From any wholesale milk vendor, whose place of "business is without the Municipality, the sum of \$10.00 "for every six months."

"(32.) From any retail milk vendor, whose place of business "is without the Municipality, the sum of \$2.50 for every "six months."

"(33.) From any dealer in explosives the sum of \$5.00 for "every six months."

"(34.) From any travelling Junk Dealer the sum of \$5.00 "for every six months."

"(35.) From any person who either on his own behalf or for "others solicits or takes orders in the Municipality for the "sale or transfer of Real Estate situate within the Munici-"pality whether such sale is to be completed outside the "Municipality or not, the sum of \$5.00 for every six months. "Provided that this section shall not apply to persons holding "a Real Estate License in respect of a business situated in "the Municipality."

"(36.) From any person following within the Municipality "any trade, occupation or calling not hereinbefore enumerated, "or who enters into any contract or agreement to perform any "work or furnish any material, \$5.00 for every six months. "Provided always that no person employed as a journeyman or "for wages only and not employing other persons shall be "subject to the provisions of this section." 6. This By-law may be cited as the "BURNABY TRADES LICENSE
