# CORPORATION OR THE DISERICT OR BURNABY. 

BY-LAM NO. 207.

TO AUTHORISS the borrowing of oertain moneye from the Royal Bank of Canada to meet the ourrent lawful expenditure of the Corporation of the Distriot of Burnaby for the zear 1916, and to set aside certain taxes to secure the same and the existing indebtedness of the said Corporation to the said Bank:

WHEREAS it is neoesgary and desirable to borrow an additional sum of $\$ 150,000.00$ from The Royal Bank of Canada to meet the currant lamful expenditure which becomes payable out of the gnnual revenue before the 1st. day of Deoember next, for the purposes set out in Sohedule "B", sttached hereto.

AND MEAREAB the said Corporation is already indebted to the said Bank in the gum of $\frac{3}{3} 25,472.56$ already borrowed.

BE IT THERFPORE GNACMRD by the Munioipal Conncil of the Corporation of the Distriot of Burnaby as follows:

1. That the said Corporation be and they are hereby authorised to borrow from the Royal Bank of Canada the sum of $\$ 150,000.00$.
2. That the said Corporation be and they are hereby authorised to pey to the said Bank interest on the said sum of $\$ 160,000.00$ at the maximum rate of six per oent per annum.
3. That the asid aum of $\$ 150,000.00$ together with intereat thereon as aforesaid shall be repayable on or before the 30th. day of September next.
4. What the aaid aum together with interest thereon shall be payable out of the municipal revenue for the ourrent year.
5. That there 1 g hereby set aside as security for the payment of the said indebtedness of \$295,472.56 and the said 20 an
of $\$ 150,000.00$ the whole of all unpaid taxes assessed and levied In any prior years in the aid municipality together with the Whole of the taxes for the current year. The said taxes so get aside as suoh security are shown in Schedule "A" attached to this By-1aw.
6. That the obligation to be given as an acknowledgment of the liability of the said Corporation of the District of Burnaby for the said loan shall be a promissory Note signed by the Reave and Clerk of the Corporation, and shall bear the corporate seal of the said Corporation,
