

THE CORPORATION OF THE DISTRICT OF BURNABY

BY LAW No. 314.

A By-law respecting certain lots in Block Eighty-five (85) of Lot 124 Group 1 in the Municipality of Burnaby and District of New Westminster .

WHEREAS application has been made to the Supreme Court of British Columbia by the Hendry Land Company Limited for Cancellation of portion (including Block 85) of Plan No. 1543 of Lot 123 and portions of Lots 122 and 124, Group One (1) New Westminster District

AND WHEREAS the Municipality is the registered owner of Lots Ten (10) to Seventeen (17) both inclusive, Block Eighty-five (85) according to said plan of subdivision

AND WHEREAS the Hendry Land Company Limited is the registered owner of the remaining lots in said Block Eighty-five (85) namely Lots one (1) to Nine (9) inclusive and Lot Eighteen (18)

AND WHEREAS the said lands belonging to the Municipality would after cancellation of said plan constitute a parcel of undesirable shape and dimensions and it is deemed desirable and expedient to convey to the Hendry Land Company Limited Lots Fourteen (14) Fifteen (15) Sixteen (16) and Seventeen (17) and to acquire from the said Hendry Land Company Limited Lots Six (6) Seven (7) Eight (8) and Nine (9) all in said Block Eighty-five (85)

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE DISTRICT OF BURNABY THEREFORE ENACTS AS FOLLOWS:

1. The Reeve and Clerk of the Municipality are hereby authorized, empowered and directed to sign, execute and deliver a Conveyance from the Municipality to the Hendry Land Company Limited a body corporate having its head office at the City of Vancouver in the Province of British Columbia of ALL

AND SINGULAR those certain parcels or tracts of lands and premises situate lying and being in the Municipality of Burnaby in the District of New Westminster in the Province of British Columbia and composed of Lots Fourteen (14), Fifteen (15) Sixteen (16) and Seventeen (17) Block Eighty-five (85) of Lot 124 Group One (1) Map 1543 and the said Clerk is hereby authorized to affix the Seal of the Corporation thereto.

2. The Municipality shall acquire by Conveyance in fee from the Hendry Land Company Limited free from all encumbrances ALL AND SINGULAR those certain parcels or tracts of lands and premises situate lying and being in the District of New Westminster aforesaid and composed of Lots Six (6), Seven (7), Eight (8) and Nine (9) Block Eighty-five (85) of Lot 124, Group One (1) Map 1543.

3. This By-law may be cited as Burnaby Property By-Law 1921, No.2.
