## BY-LAW NO. 318.

## A BY-LAW to authorise the sale of certain Tax Sale lands belonging to the Corporation of the District of Eurnaby.

WHEREAS at the Tax Sale held by the Collector of Burnaby for the year 1916 the lands described in the Schedule hereto annexed became the property of the Corporation of the District of Burnaby in default of other purchaser,

AND WHEREAS the person named in the Schedule hereto annexed has offered to purchase the lands set opposite his name in the said Schedule for the price named therein. AND IT is advisable to accept the said offers. respectively.

THE MUNICIFAL COUNCIL of the Corporation of the District of Burnaby THEREFORE ENACTS AS FOLLOWS:-

1. That the parcel of land set opposite the name of the purchaser in the Schedule hereto annexed, which Schedule is hereby incorporated with and made part of this By-law, be sold and disposed of to the person named in the said Schedule as purchaser thereof for the consideration therein expressed.

2. That upon payment of the consideration named in the said Schedule for the parcel of land sold, conveyance to the purchaser named in the said Schedule be executed under the seal of the Corporation by the Heeve and Clerk and delivered to the purchaser.

3. This Fy-law may be cited as "BURNABY LAND SALE BY-LAW, 1921, NO. 11."
