

CORPORATION OF THE DISTRICT OF BURNABY.

BY-LAW NO. 324.

A BY-LAW to acquire lands within the Municipality of Burnaby from Sabatino Faraone.

WHEREAS Sabatino Faraone is the owner of 0.16 acre portion of Block Eleven (11) District Lot Thirty-two (32), Group One (1), New Westminster District, in the Province of British Columbia, which parcel may be more particularly known and described as follows:-

Commencing at the North West corner of Block 11 in said D. L. 32, thence Southerly along the Westerly boundary of said Block 11, 204.9 feet more or less to the Northerly boundary of a 3 acre parcel of Block 11 heretofore conveyed and shewn in sketch attached to Deed No. 14196F, deposited in New Westminster Land Registry Office, thence Easterly along the Northerly boundary of said 3 acre parcel 33 feet, thence Northerly and parallel to the Westerly boundary of said Block 11, 204.9 feet more or less to the Northerly boundary thereof, thence Westerly along Northerly boundary of said Block 11 33 feet to point of commencement, said parcel containing by admeasurement 0.16 acres be the same more or less and shewn outlined in red on plan attached hereto.

AND WHEREAS the said lands are required for corporate purposes.

AND WHEREAS under the provisions of sub-section 27, of section 54 of the "Municipal Act", the Municipal Council is authorized to make and pass by-law to acquire lands.

THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE DISTRICT OF BURNABY THEREFORE ENACTS AS FOLLOWS:-

1. The 0.16 acre portion of Block Eleven (11) District Lot Thirty-two (32), Group One (1), New Westminster District, in the Province of British Columbia, shall be acquired from Sabatino Faraone, of 202 Carrall Street, Vancouver, B. C., for corporate purposes.

2. On execution and delivery of Conveyance by said Sabatino Faraone, of 202 Carrall Street, Vancouver, B. C. to the Corporation of the District of Burnaby he shall be

paid the sum of One Hundred and Fifty (\$150.00) Dollars.

3. This By-law shall take effect upon its being fully passed.

4. This By-law may be cited as "SABATINO FARAONE LAND PURCHASE BY-LAW, 1921".
