

CORPORATION OF THE DISTRICT OF BURNABY.

BY-LAW NO. 335.

A By-law to establish a road or highway through Lot "A" of Block 16 of Lot 29 Group 1 in the Municipality of Burnaby and District of New Westminster, Map 3365.

WHEREAS under the provisions of Subsection 186 of Section 54 of the "Municipal Act" in every Municipality the Council may make by-laws for establishing, opening, making, roads streets or public thoroughfares within the Municipality and for entering upon, expropriating, breaking up, taking or using any real property in any way necessary or convenient for the said purpose;

AND WHEREAS it is desirable for the purpose of extending Twelfth Avenue to Davies Street to establish a road within the Municipality of Burnaby through Lot "A" of Block 16 of Lot 29 Group 1 New Westminster District ~~Map 3365.~~

The Municipal Council of the Corporation of the District of Burnaby therefore enacts as follows:-

1. A road or highway thirty-three (33) feet in width is established, opened and made of the following described lands, namely; ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby and District of New Westminster in the Province of British Columbia, composed of portion of Lot "A" Block 16, of Lot 29 Group 1 map 3365, more particularly described as follows:- COMMENCING at the southeast corner of said Lot "A" Block 16 map 3365 thence northwesterly along the easterly boundary thereof 33 feet, thence southwesterly and parallel to the southerly boundary thereof 74.31 feet more or less to the southeast corner of Lot 44 in said Block 16 and shown on map No. 3035., thence southerly along the westerly boundary of said Lot "A" 33 feet more or less to the southwest corner thereof, thence northeasterly along the southerly boundary thereof 74.38 feet more or less to

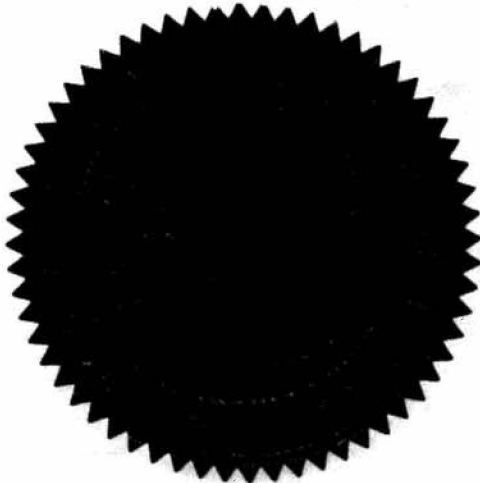
to the point of commencement as shown colored in red on the plan attached hereto.

2. This By-law may be cited as "Burnaby Road By-law (through Lot "A" Block 16 of Lot 29 group 1) 1921.

RECONSIDERED and finally passed this Third (3rd) day of October, 1921.

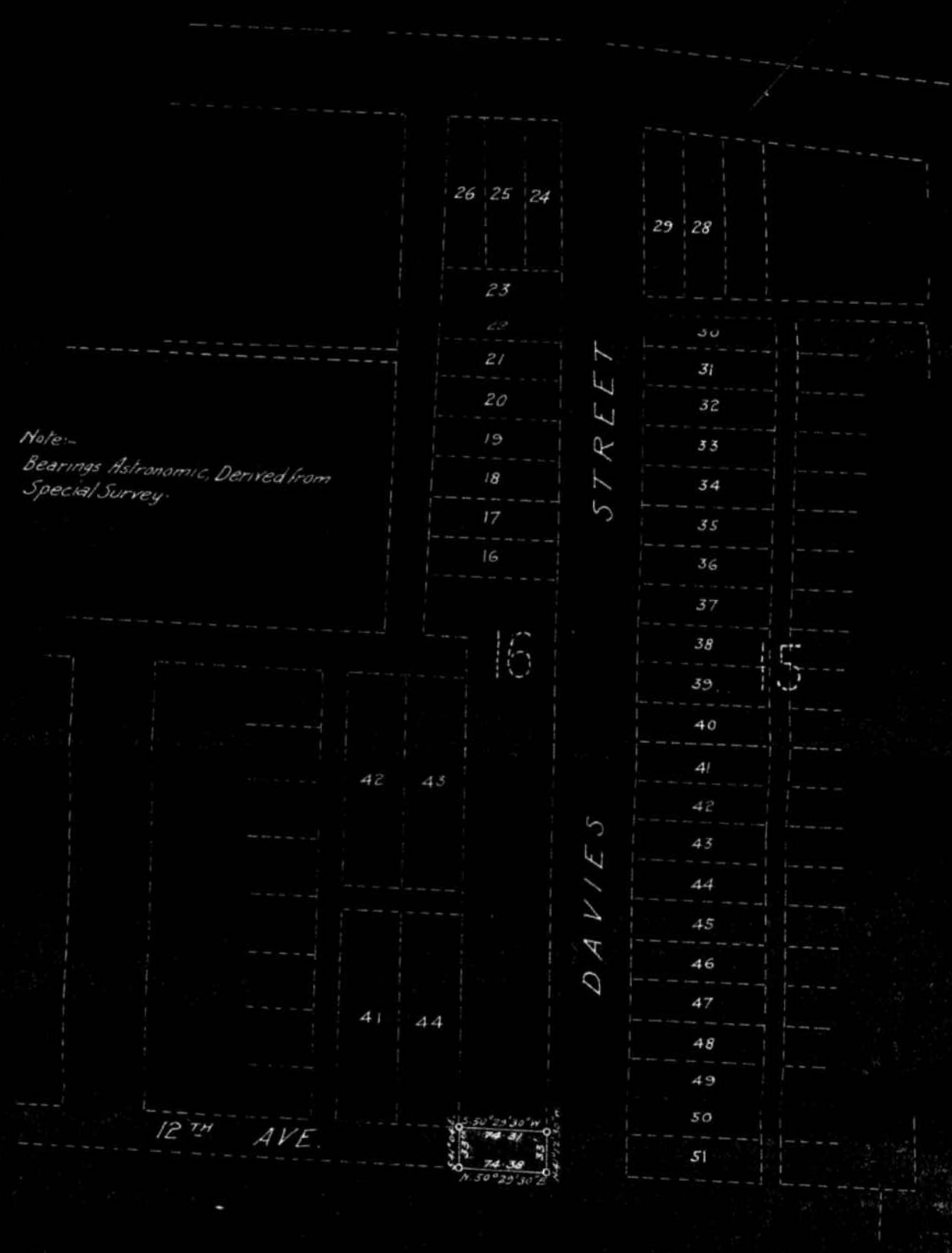
