CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 364.

A BY-LAW to authorise the execution of an Agreement between the Corporation of the District of Burnaby and His Majesty the King (in the right of the Province of British Columbia) with reference to the classification of highways within the Municipality of Burnaby.

WHEREAS the Minister of Public Works for the Province of British Columbia has designated the Hastings-Barnet Road (Dewdney) within the Municipality of Burnaby, from Boundary Road City Limits Vancouver to North Road; and North Road (Westerly half) within the Municipality of Burnaby, from City Limits New Westminster to Clarke Road (Coquitlam); and Riverway (Marine Drive) within the Municipality of Burnaby; from Boundary Road (Park Street) to south westerly boundary District Lot 172, as Secondary Highways, pursuant to Section 39, of the "Highway Act" of the Province of British Columbia and has requested the Municipal Council of the Corporation of the District of Burnaby to enter into the Agreement set out in the Schedule to this By-law approving such proposed classification;

AND WHEREAS it is expedient that such proposed classification be approved by the Municipal Council of the Corporation of the District of Burnaby and that the Agreement set out in the Schedule to this By-law be executed on behalf of the Corporation of the District of Burnaby;

NOW THEREFORE the Municipal Council of the District of Burnaby enacts as follows:-

1. That the proposed classification of the Hastings-Barnet Road (Dewdney) within the Municipality of Burnaby, from Boundary Road City Limits Vancouver to North Road; and North Road (Westerly half) within the Municipality of Burnaby, from City Limits New Westminster to Clarke Road (Coquitlam); and Riverway (Marine Drive) within the Municipality of Burnaby, from Boundary Road (Park Street) to south westerly boundary District Lot 172 as

Secondary Highways under the provisions of the "Highway Act" of the Province of British Columbia, and the routes of the said Highways, be and the same are hereby approved.

- 2. That the entering into of the proposed agreement set out in the Schedule here to be tween the Corporation of the District of Burnaby and His Majesty the King (in the right of the Province of British Columbia) is hereby approved and authorised.
- That the Reeve and Clerk be and they are hereby authorised and directed to sign the said proposed Agreement and to affix to it the corporate seal of the Municipality.
- This By-law may be cited as "BURNABY CLASSIFICATION OF HIGHWAYS BY-LAW, 1922".

SCHEDULE.

THIS AGREEMENT made and entered into this Fifth day of June A.D. 1922.

BETWEEN

THE CORPORATION OF THE DISTRICT OF BURNABY party of the one part (hereinafter referred to as "The Municipality")

and

HIS MAJESTY THE KING in the right of the Province of British Columbia, represented by the Honourable the Minister of Public Works of said Province, party of the second part (hereinafter referred to as "The Province")

WHEREAS by Section 38 of the Highway Act, being Chapter 99 of the Revised Statutes of British Columbia, 1911, enacted by Section 4 of the Highway Act Amendment Act, 1920, it is provided that for the purpose of Part 1V of the said Act, all highways shall be classified as "primary highways", "secondary highways" and "local highways", and that from time to time the said Minister shall denote the highways which in his opinion shall be classified as primary and secondary highways respectively, by delineating upon a map the route of each such highway throughout each Municipal area through or in which it runs or is intended to run.

AND WHEREAS it is further provided that as to secondary highways the said Minister shall, after agreement with and ratified by by-law of the Municipal Council of every Municipality through or within the limits of which the highway runs or is intended to run, approving of the proposed classification and route of the highway, submit the map to the Lieutenant Governor in Council for classification of the highways denoted thereon.

AND WHEREAS the said Minister has denoted on the map, a copy of which is hereto attached and made a part of this agreement, the highways which in his opinion should be classified as secondary highways by delineating on said map the route of each such highway throughout or within the limits of the area comprised in the Municipality of Burnaby.

NOW THIS AGREEMENT WITNESSETH that in consideration of the premises, it is covenanted and agreed by and between the parties hereto that the following mentioned highways through or within the limits of the said Municipalities shall be classified as secondary highways, namely:

All of which highways are denoted by the said Minister as highways which, in his opinion, should be classified as

secondary highways and the route of each such highway throughout the said Municipality delineated on the said map, a copy of which is hereby annexed.

And the Municipality doth further covenant and agree to and with the Province to approve, and doth hereby approve, of the foregoing classification and of the routes of the said highways as delineated upon said map, and that this agreement shall be forthwith ratified by by-law of the Municipal Council of the Municipality.

IN WITNESS WHEREOF the Municipality has executed these presents under the seal of the said Municipality and the hands of its proper officers in that behalf, and the Province has executed the same under the hand and seal of the said Minister of Public Works.
