

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 431.

A BY-LAW to authorise the Corporation of the District of Burnaby to acquire an Easement for Corporate purposes.

WHEREAS it is desirable and expedient that an Easement should be acquired for the purpose of constructing and maintaining a covered drain along the lands described as a portion of Lot Six (6) Block "H" of Lot One Hundred and Twenty-seven (127) Group One (1) Map 1254; as shown on the plan hereunto annexed;

AND WHEREAS John Robertson is the owner in fee of the said lands;

AND WHEREAS under the provisions of Section "A" of Sub-section 27 of Section 54 of the Municipal Act, the Municipal Council is authorised inter alia to make and to pass a By-law to acquire or accept an Easement from any person for and to the use of the Municipality.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts, as follows:-

1. It shall be lawful for the Municipal Council of the Corporation of the District of Burnaby to acquire an Easement from John Robertson, of 5104 Keefer Street, ^{Capitol Hill,} ~~Yanaburx Heights,~~ W.G.
B. C., for the purpose of constructing and maintaining a covered drain along a portion of Lot Six (6) of Block "H" of Lot One Hundred and Twenty-seven (127) Group One (1) Map 1254, as shown on the plan hereunto annexed, which parcel may be more particularly described, as follows:-

Commencing at a post set on the North Boundary of Lot 6, Block "H", D. L. 127, Group 1, New Westminster District, according to Map number 1254 deposited, 5.0 feet West of the North-east corner thereof, thence Southwardly and parallel to the East boundary of the said Lot 6, 132 feet more or less to a post set on the South boundary of said Lot 6, and 5.0 feet West of the South-east corner thereof, thence Eastwardly a distance of 5.0 feet to the South-east corner of the said Lot 6, thence Northwardly 132 feet more or less, to the North-east corner of the said Lot 6, thence Westwardly 5.0 feet to the

point of commencement as shown on the plan hereunto annexed and thereon outlined in red colour.

Paying therefor the sum of One (\$1.00) Dollar of lawful money of Canada.

2. This By-law may be cited as the "JOHN ROBERTSON EASEMENT BY-LAW, 1924."

DONE AND PASSED in open Council this Twelfth (12th) day of May, 1924.

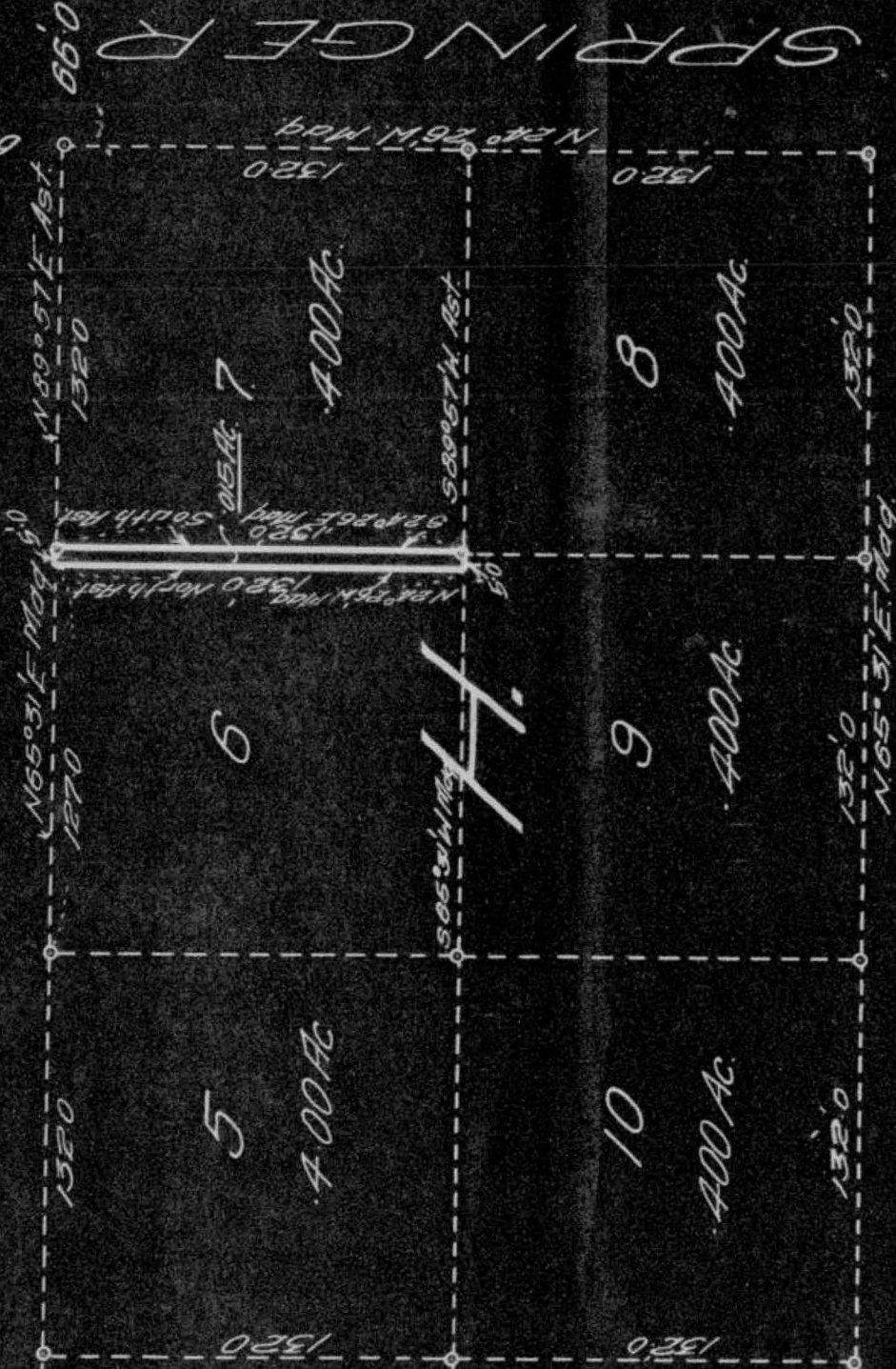
