

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 572

A BY-LAW to authorise the exchange of certain lands acquired by the Corporation under Tax Sale proceedings for certain other lands owned by D. W. Johnston.

WHEREAS the Corporation has acquired under Tax Sale proceedings the lands and premises known and described as Lots One (1) and Two(2) of Block Thirty three (33) of District Lot One hundred and eighty seven (187) Group One (1) Map No. 1282 deposited in the Land Registry Office at New Westminster, Province of British Columbia.

AND WHEREAS David William Johnston, Financial Agent, of 744 Hastings Street West, in the City of Vancouver, is the registered owner of the lands and premises known and described as the West half ($W\frac{1}{2}$) of Lot Eleven (11) of Block Forty six (46) of part of Lot Sixty nine (69) Group One, New Westminster district, according to a registered Map or plan of the said subdivision deposited in the Land Registry Office at the City of New Westminster, Province of British Columbia, and numbered 1321.

AND WHEREAS the said David William Johnston has requested the Corporation to convey to him the said lands so acquired by the Corporation under Tax Sale proceedings and to accept in full payment thereof a Conveyance of the said lands and premises owned by the said David William Johnston.

AND WHEREAS the Council deems it expedient to effect such exchange of lands.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS AS FOLLOWS:

(1) Upon the execution and delivery to the Corporation by the said ~~Wick~~ David William Johnston of a good and sufficient Deed in Fee Simple of said West half ($W\frac{1}{2}$) of Lot Eleven (11) of Block Forty six (46) of part of Lot

Sixty nine (69) Group One (1) New Westminster District, free and clear of all encumbrances whatsoever the Reeve and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a Conveyance of said Lots One (1) and Two (2) to the said David William Johnston and to deliver such Conveyance when so executed to the said David William Johnston.

2. This By-law may be cited as "D. W. Johnston Property Exchange By-law 1927"
