CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 592

A BY-LAW to acquire lands within the Municipality of Burnaby.

WHEREAS under the provisions of Sub-section 30 of Section 54 of the Municipal Act the Municipal Council is authorised to make and pass By-laws to acquire lands.

AND WHEREAS it is desirable and expedient that the Westerly Thirty three (33') feet of a Two (2) acre portion of Block Ten (10) District Lot Ninety nine (99) Group One (1) New Westminster District should be acquired.

THEREFORE the MUNICIPAL COUNCIL of the CORPORATION OF THE DISTRICT OF BURNABY ENACTS as follows:-

1. The Westerly Thirty three (33*) feet of a Two (2) acre portion of Block Ten (10) District Lot Ninety nine (99) Group One (1) District of New Westminster, according to Map No. 844 and Sketch #5995 deposited, and being more particularly Rescribed as follows:

Commencing at the Southwest corner of Block 10 aforesaid; thence Northwardly and following the West boundary of said Block 10, 417.9 feet to a post set at the Northwest corner of a 2.00 acre portion of said Block 10, heretofore conveyed and shown on Sketch deposited #5995;

thence Eastwardly and following the North boundary of said 2.00 acre portion, 33.0 feet to an iron pin; thence Southwardly and parallel to the West Boundary of said Block 10, 417.72 feet to a post set on the South Boundary thereof;

thence Westwardly and following the South boundary of said Block 10, 33.0 feet to the point of commencement, and containing by admeasurement, 0.318 of an acre, be the same more or less, as shown on the plan hereunto annexed and thereon outlined in red colour

shall be acquired from

.

2. On execution and delivery of conveyance by the said James Robert Dickson, to the Corporation of the District of Burnaby, he shall be paid the sum of One (\$1.00) Dollar.

3. This By-law may be cited as the "J.R.DICKSON PROPERTY FURCHASE BY-LAW 1927"
