

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 600

A BY-LAW to authorise the disposal of all rights, Title and Interest of the Corporation of the District of Burnaby in Lot 9, in the subdivision of Lots 78 and 44, Group 1, New Westminster District,

WHEREAS the Vancouver and Districts Joint Sewerage and Drainage Board, created under the "Vancouver & Districts Joint Sewerage and Drainage Act", being Chapter 79 of the Statutes of British Columbia, 1914, is desirous of changing the channel of Still Creek through Lots Twenty (20) and Nine (9) of a subdivision of Lots Seventy eight (78) and Forty-four (44) Group One, New Westminster District.

AND WHEREAS <sup>Center</sup> ~~the North and South banks of~~ Still Creek Al. H. forms the boundary lines of the said Lots Twenty (20) and Nine (9) Respectively.

AND WHEREAS it is necessary for the purpose aforesaid to change the said boundary lines of the said lots Twenty (20) and Nine (9)

AND WHEREAS John Harrison Muesse is the owner in fee of Lot Nine (9) District Lot Seventy-eight (78) and Forty-four (44) Group One (1) New Westminster District.

AND WHEREAS The Corporation of the District of Burnaby is the owner in fee of Lot Twenty (20) District Lot Seventy-eight (78) and Forty four (44) Group One, New Westminster District.

AND WHEREAS it is desirable and expedient that the Corporation of the District of Burnaby should grant and quit claim all its Right, Title and Interest in Lot Nine (9) in the subdivision of Lots seventy eight (78) and Forty four (44) Group One (1) New Westminster District, Map No. to the said John Harrison Muesse, and that the Corporation of the District of Burnaby should accept a Quit claim from the said John Harrison Muesse of all his right, title and interest in the said Lot Twenty (20) in the subdivision of Lots seventy-eight (78) and Forty four (44) Group One (1) New Westminster

District, Map No. .

NOW THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:

1. It shall be lawful for the Reeve and the Clerk to execute under the seal of the Corporation a Quit Claim Deed to John Harrison Muesse, of the City of Vancouver, granting, releasing, and quit claiming all its right, title interest, claim and demand whatsoever in Lot Nine (9) in District Lots Seventy-eight (78) and Forty-four (44) Group One (1) New Westminster District, Map No. .

2. This By-law may be cited as the "D.L.78.Property Sale By-law 1927"
