## CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 746.

A By-law to authorise the sale to Harriet Bookey of Hast half of Lot Two (2) of Block Eight (8) of Lot Ninety three (93) Group One (1) New Westminster District.

WHEREAS the lands hereinafter mentioned were acquired by the Corporation of the District of Burnaby from Margret Ann Thomas. Widow, of 2623 Windsor Street, under authority of By-law No. 460 of the Corporation.

AND WHEREAS Harriet Bookey, widew, of 2623 Windsor Street, in the Municipality of Burnaby, Province of British Celumbia, has offered to purchase the said lands for the sum of Eight hundred (\$800.00) dollars on terms hereinafter mentioned and it is desirable to accept the said offer.

NOW THEREFORE THE MUTEICIPAL COUNCIL OF THE CORPORATION OF THE DISTRICT OF BURNABY ENACTS AS FOLLOWS:

1. The East half of Lot Two (2), of Block Right (8) of Let Ninety three (93) Group One (1) Map 1525, New Westminster District, shall be sold to Harriet Bookey, Widow, of 2623 Windser Street, in the Municipality of Burnaby, Prevince of British Columbia, for the sum of Right hundred (\$800.00) dellars, payable, as follows:-

Two hundred (\$200.00) dollars on the execution and delivery of the Agreement for sale hereinafter mantismed

Two hundred (\$200.00) dollars on the 1st day of July, 1929

Two hundred (\$200.00) dollars on the 1st day of July, 1936.

Two hundred (\$200.00) dellars on the 1st day of July, 1931

with interest on the purchase money from time to time remaining uppaid at the rate of six (6%) per cent. per annum with each instalment.

- 2. An Agreement for Sale and purchase of the said lands in the terms hereinbefore mentioned shall be executed under the seal of the Corporation by the Reeve and Clerk.
- 3. Upon payment by the purchaser of the purchase money aforesaid and on compliance with the terms of the said agreement for Sale, Conveyance of the said lands shall be executed under the Corporate seal of the Corporation of the District of Burnaby by the Reeve and Clerk and delivered to the said Harriet Bookey.
- 4. This By-law shall take effecton its being finally passed.
- 5. This By-law may be cited as "MARGRET ANN THOMAS PROPERTY SALE BY-LAW 1928."
