

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 746.

A By-law to authorise the sale to Harriet Boekey  
of East half of Lot Two (2) of Block Eight  
(8) of Lot Ninety three (93) Group One (1)  
New Westminster District.

WHEREAS the lands hereinafter mentioned were acquired  
by the Corporation of the District of Burnaby from Margret  
Ann Thomas, Widow, of 2623 Windsor Street, under authority  
of By-law No. 460 of the Corporation.

AND WHEREAS Harriet Boekey, widow, of 2623 Windsor  
Street, in the Municipality of Burnaby, Province of  
British Columbia, has offered to purchase the said lands  
for the sum of Eight hundred (\$800.00) dollars on terms  
hereinafter mentioned and it is desirable to accept the  
said offer.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION  
OF THE DISTRICT OF BURNABY ENACTS AS FOLLOWS:

1. The East half of Lot Two (2), of Block Eight (8)  
of Lot Ninety three (93) Group One (1) Map 1525, New  
Westminster District, shall be sold to Harriet Boekey,  
Widow, of 2623 Windsor Street, in the Municipality of  
Burnaby, Province of British Columbia, for the sum of  
Eight hundred (\$800.00) dollars, payable, as follows:-

Two hundred (\$200.00) dollars on the execution  
and delivery of the Agreement for sale herein-  
after mentioned

Two hundred (\$200.00) dollars on the 1st day of  
July, 1929

Two hundred (\$200.00) dollars on the 1st day of  
July, 1930.

Two hundred (\$200.00) dollars on the 1st day of  
July, 1931

with interest on the purchase money from time to time  
remaining unpaid at the rate of six (6%) per cent. per  
annum with each instalment.

2. An Agreement for Sale and purchase of the said lands in the terms hereinbefore mentioned shall be executed under the seal of the Corporation by the Reeve and Clerk.

3. Upon payment by the purchaser of the purchase money aforesaid and on compliance with the terms of the said Agreement for Sale, Conveyance of the said lands shall be executed under the Corporate seal of the Corporation of the District of Burnaby by the Reeve and Clerk and delivered to the said Harriet Boekey.

4. This By-law shall take effect on its being finally passed.

5. This By-law may be cited as "MARGRET ANN THOMAS PROPERTY SALE BY-LAW 1928."
