A By Law

To authorize the Council to borrow the sum of five thousand Dollars repayable during the current year in terms of schedule 1000 sub section 1000 of the Municipal Act 1892.

Be it enacted by the Mayor and Council of the Corporation of the District of Burrard, in Council assembled as follows by

1. The Council are hereby authorized to borrow for any purpose or purposes, Company or Corporation and that in one sum or sums, an amount of Money not exceeding in all the sum of five thousand Dollars of the lawful Money of Great Britain to pay thereof at the rate of interest...

eight per centum per annum, and that for the purpose of meeting
the current legal expenditures of the Corporation, which are paid
out of the Annual revenues, before the revenues for the year are
paid by the tax payers.

2. The Money so borrowed, together with the interest thereon, shall
be made payable and shall be repaid on or before the 1st day
of October 1895 - out of the Municipal revenues of the Council
year.

3. The obligation to be given to the lender or lenders, shall
be a Note or Notes signed by the Mayor, the Finance Committee
and the Clerk of the Council, and sealed with the Corporation
Seal, and in all respects as may be to the following form to wit:

Buenos Aires (date of issue) 1895

The Corporation of the District of Buenos Aires, promises
to pay to (Name of lender) or order, the sum of (sum borrowed)
of the lawful Money of Canada, with interest at the rate of
(rate of interest) per centum per annum on the date of issue
1895.

This by law shall take effect on the 15th day of Feb
ruary 1895.

"The Buenos Aires Loan By Law 1895"
