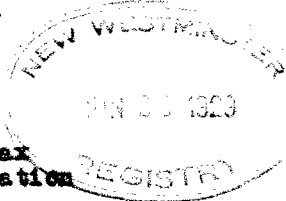


CORPORATION OF THE DISTRICT OF BARNABY

BY-LAW NO. 908.



A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Barnaby.

WHEREAS at the Tax Sales held by the Collector of Barnaby for the years 1918, 1919, 1920, 1922, 1923, 1924, 1925, 1926 and 1927 the lands described in the schedules marked "A", "B", "C", "D", "E", "F", "G", "H" and "I" hereto annexed became the property of the Corporation of the District of Barnaby in default of other purchaser.

AND WHEREAS the person named in the several Schedules marked "A", "B", "C", "D", "E", "F", "G", "H" and "I" hereto annexed has offered to purchase the lands set opposite his name in the said Schedules for the price named therein, AND it is advisable to accept the said offers, respectively.

THE MUNICIPAL COUNCIL of the Corporation of the District of Barnaby therefore enacts as follows:-

1. That the parcel of land set opposite the name of the purchaser in the several schedules marked "A", "B", "C", "D", "E", "F", "G", "H", and "I" hereto annexed, which Schedules are hereby incorporated with and made part of this by-law, be sold and disposed of to the person named in the said Schedules as purchaser thereof for the consideration therein expressed.

2. That upon payment of the consideration named in the said Schedules for the parcel of land sold, conveyance to the purchaser named in the said schedules be executed under the seal of the Corporation by the Reeve and Clerk and delivered to the purchaser.

3. "Burnaby Land Sale By-law No. 6. 1922" being By-law No. 372 of this Corporation is hereby amended by striking out the following item, in Schedule "G":-

4. "Burnaby Land Sale By-law No.2. 1927" being By-law No. 588 of this Corporation is hereby amended by striking out the following item, in Schedule "G"

Cordova St. Vancouver, B.C. \$2,200.00

5. This By-law may be cited as "Burnaby Land Sale By-law No. 6. 1929.

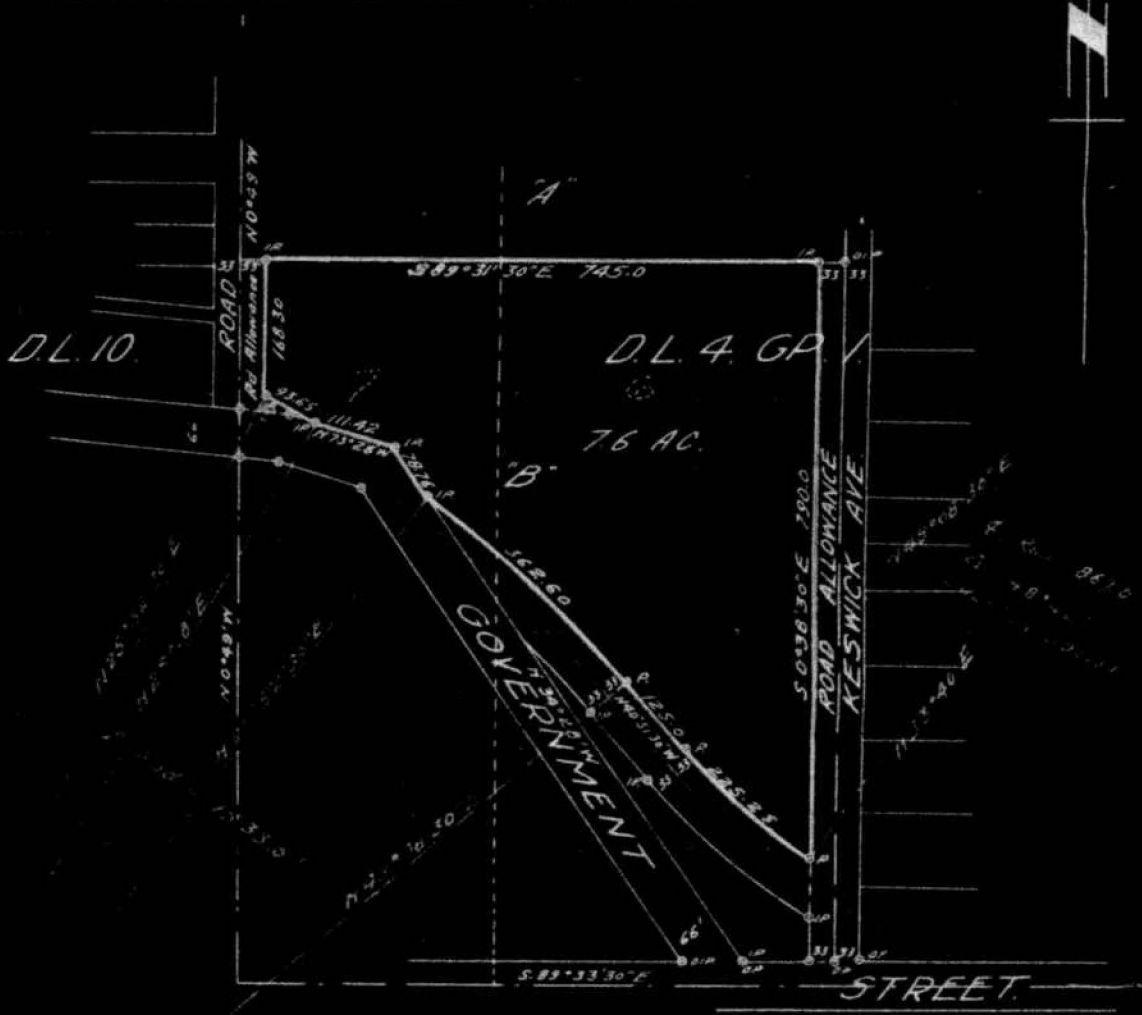
