AND WHEREAS the person named in the several Schodules marked "A", "B", "W", "D", "E", "F", "F", "R", "H" and "I" herete annexed has effered to purchase the lands set opposite his name in the said Schodules for the price named therein, AND it is advisable to accept the said offers, respectively.

THE MUNICIPAL COUNCIL of the Corporation of the District of Burneby therefore enacts as follows:-

- 1. That the parcel of land set opposite the mame of the purchaser in the several schedules marked "A", "B", "G", "B", "G", "B", "G", "B", and "I" hereto annexed, which Schedules are hereby incorperated with and made part of this by-law, be sold and disposed of to the person named in the said Schedules as purchaser thereof for the consideration therein expressed.
- 2. That upon payment of the consideration named in the said Schedules for the parcel of land sold, conveyance to the purchaser named in the said schedules be executed under the seal of the Corporation by the Reeve and Clerk and delivered to the purchaser.
