

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 927

A BY-LAW to authorize the sale of certain lands acquired by the Corporation of the District of Burnaby under Tax Sale proceedings, and to accept in full payment therefor other lands owned by the Board of School Trustees of the Municipal District of Burnaby.

WHEREAS the Corporation has acquired under Tax Sale proceedings the lands and premises known and described as Lots One (1) to Eighteen (18) inclusive, of Block Forty-five (45) District Lot One hundred and Twenty three (123) Group One (1) New Westminster District, Map No. 1543;

AND WHEREAS the Board of School Trustees of the Municipal District of Burnaby, is the registered owner of the lands and premises known and described as Lots One (1) to Five (5) inclusive, and Lots Fourteen (14) to Eighteen (18) inclusive, of Block Five (5) of a subdivision of the Easterly quarter of District Lot One hundred and twenty seven (127E $\frac{1}{2}$) Group One (1) New Westminster District, Map No. 1542;

AND WHEREAS the said Board of School Trustees of the Municipal District of Burnaby has requested the Corporation to convey to it the said lands so acquired by the Corporation under Tax Sale proceedings and to accept in full payment therefor a conveyance of the said lands and premises owned by the said Board of School Trustees;

AND WHEREAS the Council deems it expedient to effect such exchange of lands:

THEREFORE THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby ENACTS AS FOLLOWS:

(1) Upon the execution and delivery to the Corporation by the said Board of School Trustees of a good and sufficient

Deed in Fee Simple of said Lots One (1) to Five (5) inclusive and Lots Fourteen (14) to Eighteen (18) inclusive of Block Five (5) of subdivision of the Easterly quarter of District Lot One hundred and twenty seven (127E^{1/2}). Group One (1) Map No. 1342, New Westminster District, free and clear of all encumbrances whatsoever, the Reeve and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a Conveyance of said Lots One (1) to Eighteen (18) inclusive of Block Forty five (45) of District Lot One hundred and twenty three (123) Group One (1) New Westminster District, Map No. 1543, to the said Board of School Trustees.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 3. 1929."
