A BY-LAW to authorise the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby

- (1). That the parcel of land set opposite the name of the purchaser in the several schedules marked "A", "B" and "C" hereto annexed, which Schedules are hereby incorporated with and made part of this By-law, be sold and disposed of to the person named in the said Schedules as purchaser thereof for the consideration therein expressed.
- (2) That upon payment of the consideration named in the said Schedules for the parcel of land sold, conveyance to the purchaser named in the said schedules be executed under the seal of the Corporation by the Reeve and Clerk and delivered

to the purchaser.

(3) This By-law may be cited as "BURNABY LAND SALE BY-LAW NO. 11. 1929."
