

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 993.



A BY-LAW to enable the Corporation to accept a conveyance of certain lands from George HOFFMAN in the Municipality of Burnaby, for Corporate purposes.

WHEREAS one George Hoffman a resident of the Municipality of Burnaby has been admitted to the Provincial Home for Incurables as a charge upon the Corporation of the District of Burnaby.

AND WHEREAS the said George Hoffman is the owner in fee of certain lands within the Municipality of Burnaby described as Lots Forty two (42) and Forty three (43) of subdivision of District Lot One hundred and thirty two (132) Group One (1) New Westminster District, Map No. 1493.

AND WHEREAS the said George Hoffman has sold the aforementioned lands under Articles of Agreement dated the Eleventh (11th) day of February, A.D. 1926 to Emily Alice Stuart and James Stuart, of Lochdale, in the Municipality of Burnaby:

AND WHEREAS the said George Hoffman has agreed to convey to the Corporation of the District of Burnaby his right, title and interest in the said lands subject to the aforementioned articles of agreement:

AND WHEREAS it is deemed expedient that conveyance of the said lands should be accepted by the Corporation:

THEREFORE the Municipal Council of the Corporation of the District of Burnaby, ENACTS AS FOLLOWS:-

1. It shall be lawful for the Corporation to accept from the said George Hoffman a conveyance of Lots Forty two (42) and Forty three (43) of subdivision of District Lot One hundred and thirty two (132) Group One (1) Map No.1493, subject to the Articles of agreement dated 11th day of February, 1926, between the said George Hoffman and Emily Alice Stuart and James Stuart,

registered as Charge No. 63871C. in the Land Registry office at New Westminster, Province of British Columbia.

2. That upon payment by Emily Alice Stuart and James Stuart of the balance of the principal sum due and accruing under the said Agreement for Sale together with the interest thereon, the Reeve and Clark are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a Conveyance of said Lots Forty two-(42) and Forty three (43) to the said Emily Alice Stuart and James Stuart, and to deliver such conveyance when so executed to the said Emily Alice Stuart and James Stuart.

3. This By-law may be cited as "GEORGE HOFFMAN PROPERTY ACQUISITION BY-LAW 1929."

DONE AND PASSED in Open Council this Second (2nd) day of December, A.D. 1929.

RECONSIDERED and FINALLY PASSED by a three-fourths affirmative vote of all the members of the Council on the Sixteenth (16th) day of December, A.D. 1929.
