

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1001.

A BY-LAW to authorise the sale of certain lands acquired by the Corporation under tax sale proceedings and to accept in part or full payment other lands in the Municipality owned by Christina Munro.

WHEREAS the Corporation has acquired under Tax Sale proceedings the lands and premises known and described as Lot Thirty three (33) Block Twelve (12) District Lot One hundred and eighty nine (189) Group One (1) New Westminster District, Map No. 1289;

AND WHEREAS Christina Munro (Spinster) of 1358 17th Avenue East, in the City of Vancouver, is the registered owner of the lands and premises known and described as Lot Twenty eight (28) of Block Twenty three (23) District Lot One hundred and eighty nine (189) Group One (1) New Westminster District, Map No. 1289.

AND WHEREAS the said Christina Munro has requested the Corporation to convey to her the said lands so acquired by the Corporation under Tax Sale proceedings and to accept in full payment therefor a conveyance of the said lands and premises owned by the said Christina Munro together with the sum of Twenty five (\$25.00) dollars.

AND WHEREAS the Council deems it expedient to effect such exchange of lands.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts as follows:-

(1) Upon the execution and delivery to the Corporation by the said Christina Munro, (Spinster) of a good and sufficient Deed in Fee Simple of Lot Twenty eight (28) Block Twenty three (23) District Lot One hundred and eighty nine (189) Group One (1) New Westminster District, Map No. 1289, free and clear of all encumbrances whatsoever, together with the sum of Twenty five (25.00) dollars, the Reeve and

Clerk of the Corporation are hereby authorized and empowered to execut and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of said Lot Thirty three (33) Blook Twelve, (12) District Lot One hundred and eighty nine (189) Group One (1) New Westminster District, Map No. 1289, to the said Christina Munro and to deliver such Conveyance when so executed to the said Christina Munro.

(2) This By-law may be cited as "Burnaby Property Exchange By-law No.6. 1929."
