

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1002

A BY-LAW to further amend the "Burnaby Waterworks Regulation By-law No. 2. 1926."

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby enacts as follows:-

1. The Burnaby Waterworks Regulation By-law No. 2. 1926 being By-law No. 521, of this Corporation, is hereby amended by cancelling the schedule "A" attached thereto, and by substituting therefor the Schedule attached to this By-law.

2. This By-law shall come into effect on the First (1st) day of January, A.D. 1930.

3. This By-law may be cited as the "Burnaby Waterworks Regulation By-law No. 2. 1926 Amendment By-law No. 3. 1929."

DONE AND PASSED in Open Council this Second (2nd) day of December, A.D. 1929.

RECONSIDERED AND FINALLY PASSED this Sixteenth (16th) day of December, A.D. 1929.

FLAT RATES.

Seven dollars and Fifty cents (\$7.50) for each period of six (6) months subject to a discount of One (\$1.00) dollar for each period of six (6) months if paid on or before the 31st. day of the month in which the same may be payable.
